Guatemala - A4P Strategic Area 1: Fostering the Productive Sector

USAID Activities That Align

Promoting loans to Guatemalan companies, with an emphasis on community forest concessions, as well as micro, small and medium forest enterprises

Promoting regional agricultural trade by building public and private sector sanitary and phytosanitary standards (SPS) capacity and improving access to markets

Expanding smallholder farmers' access to commercially viable new or innovative agricultural inputs and technologies through the development of public-private partnerships

Improving horticulture extension and access to credit in Guatemala for smallholder farmers, producing crops for export and local markets as well as home consumption

Establishing a Sustainable Economic Observatory--an independent research center/think tank--to strengthen the participation and contribution of civil society, the public and private sectors, and other stakeholders in dialogue, analysis, design, and implementation of effective policies and programs at the national and local levels

Supporting the development and strengthening of market-driven, community level conservation, such as timber and non-timber value chains

Providing technical assistance and training on best agricultural practices and post-harvest management practices

Guatemala - A4P Strategic Area 2: Developing Human Capital

USAID Activities That Align

Creating educational, athletic, cultural, and employment opportunities for youth

Improving food security and nutrition and increasing income generation for rural households in Guatemala's Western Highlands by consumption of animal protein, cooperatives' governance and transparency, small business owner's negotiation skills, and increasing household's income generation, and addressing household nutritional deficiencies

Reducing poverty, food insecurity, and malnutrition, while increasing the sustainability and resilience of maize-based farming systems, decreasing environmental degradation, and improving the livelihoods of small-scale, resource-poor farmers

Supporting more than 3,000 smallholder farmers in increasing their capacity to implement integrated pest management practices and stimulate sales of biological pest control products

leverages migrant investments, diaspora donations and remittances to build both human and economic capital

Increasing access to and the quality of potable water

Improving the quality of health interventions at the household, community, and health facility levels

Strengthening local capacities and supporting the implementation of bilingual education (Mayan languages and Spanish) in primary schools

Guatemala - A4P Strategic Area 3: Improving Citizen Security and Access to Justice

USAID Activities That Align

Supporting security and justice sector reforms, enforcement of key legislation, and promotion of civic responsibility

Developing the capacity of civil society organizations so they can play a more effective role in addressing citizen security, government accountability, and corruption issues

Supporting efforts by Government of Guatemala, civil society, and community actors to address the causes and consequences of violence through holistic prevention approaches

Supporting the protection of underage girls and adolescents who are victims of trafficking by ensuring they receive comprehensive care and legal support; Strengthening the prevention of trafficking in persons through training, coordination, and communication campaigns

Improving the provision of services for victims of violence, including youth, women, and other vulnerable populations; Improving the Government of Guatemala's juvenile justice system in order to reduce recidivism in juvenile offenders

Supporting 80 community-based violence prevention projects; strengthening and mobilizing municipal and national stakeholders and resources to develop and implement municipal-level violence and migration prevention plans; promoting the involvement of the private sector (local, national, and/or international) in violence migration and prevention activities

Improving living conditions and municipal services in high-crime, informal settlements; and support efforts so that citizens in the most at-risk communities are actively involved in municipal decision-making and accountability processes

USAID Activities That Align

Assisting the Government of Guatemala in the implementation of the National Transparency Policy

Helping the Government of Guatemala to provide juvenile justice services, services for gender-based violence victims, and strengthen its response to Trafficking in Persons (TIP)

Ensuring that municipalities have strong public budgeting & service delivery processes in place

Increasing the capacity of local governments to raise revenue; respond to citizen concerns related to violence and security, food insecurity, and global climate change; and manage public resources in a participatory and financially sound manner

Using a community-based development approach to identify development priorities, ranging from increasing access to schools and community centers to expanding drinking water supplies and sanitation services

Building a representative cadre of future political leaders in Guatemala who are able to address some of the country's most pressing challenges

Supporting the development and implementation of key reforms and increase the transparency and accountability of electoral processes in Guatemala

Increasing the collection and management of public resources by providing policy advice and capacity building on public financial management issues

Establishing a Sustainable Economic Observatory--an independent research center/think tank

Assisting the Guatemalan Ministry of Agriculture in implementing a public-private SPS inspection system to increase the country's compliance with international SPS standards

Developing and implement a LEDS Project and build institutional capacity within the government to reduce the effects of climate change and mitigate greenhouse gas emissions

Strengthening environmental governance in the Maya Biosphere Reserve

Providing direct support to local governments to improve the health conditions of eight municipalities in Quetzaltenango, including increasing access to and the quality of potable water

Strengthening the agriculture- and food security-enabling environment; working with central- and municipal-level governments to implement rural development, agriculture, and food security policies

Supporting targeted health sector reform and central-level planning and policies in the education, nutrition, and health sectors

Strengthening government response to violations of the human rights of LGBTI people

Supporting the Ministry of Health in its efforts to improve the supply chain and expand the availability of micronutrients, vaccines, contraceptives, and other essential medicines

Implementing human resource development programs for Ministry of Education personnel

Increasing the coverage and use of Ministry of Health supported reproductive, maternal, newborn, child and adolescent health, family planning, and nutrition interventions at the

USAID Activities That Align

Strengthening capacity of micro, small, and medium (MSME) enterprises to compete in domestic and export markets

Promoting linkages between private sector needs and training centers to develop a long-term relationship in which youth are tailor-trained for existing opportunities with a private sector client

Strengthening the science, technology, research, and innovative capacity in El Salvador higher education with a focus on disciplines that contribute to economic growth

Supporting the revival of cocoa market in El Salvador, targeting international specialty and gourmet markets, while supporting sustainable development and conservation of natural resources

Mobilizing approximately \$35 million in loans with two banks for micro, small and medium firms (MSMEs)

Mobilizing approximately \$53.8 million in loans for Small and Medium Enterprise development, and clean energy and energy efficiency projects

Providing youth with training to develop entrepreneurial and managerial skills and helping them develop business ideas into microenterprises that fulfill unsatisfied demand by industrial companies

USAID Activities That Align

Improving quality and access to education and provide safe learning environments for students

Providing underprivileged youth with English, computer training, and life skills

Improving services for the protection of returning migrants including vulnerable populations, such as unaccompanied children (UAC) and families

Supporting technical education training providers, civil society organizations, the Salvadoran government, and the private sector to increase and improve employment of at-risk youth living in high-crime municipalities prioritized by the Government of El Salvador under Plan El Salvador Seguro

Building the human and institutional capacity of Salvadoran higher education institutions and the effectiveness of key government and Higher Education Institutions (HEI) to provide educational programs and research that contribute to the country's economic growth by responding to industry needs

Providing youth with training to develop entrepreneurial and managerial skills and helping them develop business ideas into microenterprises that fulfill unsatisfied demand by industrial companies

USAID Activities That Align

Increasing safety for citizens of El Salvador by supporting the GOES National Strategy on Violence Prevention and by expanding the municipal-led, community-based crime and violence prevention efforts

Bringing together five of El Salvador's leading foundations to help prevent crime and violence in El Salvador; leveraging an additional \$22 million from the private sector for crime and violence prevention activities in key municipalities

Providing support to the Government of El Salvador to reduce impunity and improve citizen trust in government institutions.

Strengthening governmental and non-governmental human rights protection systems to enhance the protection of human rights in El Salvador, resulting in an increasingly tolerant, just, and equitable El Salvador

USAID Activities That Align

Providing support to the government to reduce impunity and improve citizen trust in government institutions by strengthening the justice sector

Working in partnership with central and municipal-level Government institutions to improve transparency and accountability, with a focus on Government integrity

Strengthening Government and non-governmental human rights protection systems to enhance the protection of human rights in El Salvador, resulting in an increasingly tolerant, just, and equitable nation

Providing services to help returning migrants reintegrate into local communities and to alert the public on the risks of irregular migration;

Strengthening decentralization and local government capacity in El Salvador to increase security and development

Enabling the juvenile justice system to better reintegrate and reduce recidivism rates for children in conflict with the law

Assisting the government to improve public financial management practices, increase domestic resources mobilization, and generate additional revenue.
