## Overview of Contraceptive and Condom Shipments

The U.S. Agency for International Development (USAID) has provided commodities for family planning and reproductive health activities since the mid-1960s. Thanks to USAID and other international donors, the use rates for contraceptives and condoms have increased in most parts of the world. In fiscal year (FY) 2015, USAID continued to respond to the increasing need for foreign assistance by providing family planning and reproductive health commodities to Missions in four of the five agency's regions: Africa, Asia, Europe and Eurasia (E&E), and Latin America and the

Caribbean (LAC). No shipments were sent to the Middle East region in FY 2015.

In 1990, to support this worldwide effort, a centralized system—the Central Contraceptive Procurement Project—was created to provide the contraceptives and condoms needed in USAID's field programs. The Commodities Security and Logistics (CSL) Division of USAID's Office of Population and

Reproductive Health was tasked with administering this system. The division works with country programs and other donors to provide technical leadership, ensure that commodities are available to anyone who wants to use them, support a program for improved supply chain design and logistics management in developing countries, and maintain a database for USAID commodity assistance.

USAID Missions determine the quantity and type of contraceptives and condoms that they need for their programming; they place orders with the CSL division for these commodities. This report includes details of data gathered in FY 2015 on those contraceptive and condom shipments. The data analysis is organized by a worldwide overview, USAID region, and commodity type. The report includes details on both the value and quantity of shipments from FY 2013–2015. It should be noted that one-year fluctuations in contraceptive and condom shipments at the regional- and country-levels are not necessarily the result of programmatic shifts. In fact, variations in country supply plans and shipment schedules from one year to the next often account for these fluctuations.

### Commodity Fund

The Commodity Fund (CF) provides central funding to procure male and female condoms for HIV and AIDS programs and it ensures their expedited delivery to USAID-supported countries. Since its inception in FY 2002, the annual funding for the CF has ranged from U.S. \$10.1 million to \$31.9 million. In FY 2015, the funding allocated to the CF totaled \$22.9 million.

The value of condom orders shipped by CF, and paid for in FY 2015, totaled \$21.7 million. Of the \$21.7 million, 75 percent was for male condoms and 25 percent was for female condoms—a slightly higher value for female condoms compared with FY 2013 and FY 2014.

### Worldwide Contraceptive and Condom Shipments

- The worldwide 10-year trend in the value of contraceptive and condom shipments is increasing. FY 2015 was the second highest total value shipped in the past decade (see figure 1).
- USAID continued to focus on sending resources to regions with the greatest need. In FY 2015, Africa requested 70 percent of the worldwide shipments, followed by Asia; significantly lower values were directed to the LAC and the E&E regions. For the second year in a row, the Middle East did not have shipments in FY 2015 (see figure 2).
- All regions showed an increase in value of shipments during FY 2015. The most significant percentage change was in the E&E, because of the large condom shipments for Ukraine. The largest change in absolute value was in Africa where shipment values increased by \$11 million (see table 1).
- Contraceptive implants sharply increased in quantity for the past three years, while the value has fluctuated for implants because of the unit price reductions seen in FY 2013 and 2014. In FY 2015, both the quantity and value increased over FY 2014 (see table 3). The spike in quantity for FY 2015 was attributed largely to Tanzania (see table 11).
- Increasing slightly in value and quantity, compared to FY 2014, male condom shipments continued the trend started in FY 2013 of holding the largest share of commodity values shipped worldwide. Injectable contraceptives were second for the second year in a row, but it trailed by \$5 million in value (see figure 3 and table 2).
- Intrauterine devices (IUDs) were the only method to decline in FY 2015, as quantities and values shipped to Pakistan greatly decreased (see tables 2, 3, and 12).
- Government programs again received most of the world-wide contraceptive and condom shipments in FY 2015, followed by social marketing, nongovernmental organizations (NGO), and research (see figure 4).
- Government shipment values worldwide have increased since FY 2010. This is largely due to the significant support to Asia—Pakistan, in particular—and to Africa; governmental support is leveling off at just over 50 percent. Overall support to NGOs has decreased during recent years (see figure 5).







# Contraceptive and Condom Shipments to Africa

- Africa is the region that has received the largest amount of support from USAID. FY 2015 shipment values increased to the highest value seen in the region for the past 10 years. Contraceptive shipments have contributed greatly to the noted upward 10-year trend in Africa (see figure 6 and table 4).
- In FY 2015, 32 African-region countries requested commodities, an increase over the 28 countries that requested orders in FY 2014 and 24 countries in FY 2013 (see table 4).
- Similar to previous years, all methods are well represented in shipments to Africa, except IUDs, which again accounted for only 1 percent of the value shipped in FY 2015 (see figure 7).
- Nigeria, Madagascar, Tanzania, Zambia, and Zimbabwe requested the largest value shipments in FY 2015. These countries' orders all represent an increase over the previous year. Across the past three years, Tanzania and Zimbabwe show an increasing trend in quantity and value (see figure 8 and table 4).
- Malawi, Kenya, and Uganda saw a decline in shipment values during the past three years as shipments to publicsector programs in Malawi and Kenya, and a social marketing program in Uganda, decreased (see table 4).
- Government programs in Africa continued as the primary program type this year, receiving more than half the shipment values—a greater share than last year. Social marketing and NGO programs decreased slightly in FY 2015; research programs received support for the first time since FY 2005 (see figures 9 and 10).







# Contraceptive and Condom Shipments to Asia

- Shipment values to Asia rose dramatically in FY 2011 because of the increased support to Bangladesh and Pakistan. Values shipped to the region in the past three years have leveled off, as support to Bangladesh has diminished (see figure 11 and table 5).
- Seven countries in the Asia region requested commodities in both FY 2015 and FY 2013—an increase over the six countries that placed orders in FY 2014 (see table 5).
- The region requested shipments for all methods, including female condoms, which were not represented in the region's method mix in FY 2014 (see figure 12).
- Implants to the region are the only commodity that has increased in value and quantity during the past three years; injectables and IUDs have declined, while male condoms, female condoms, and orals have fluctuated.





Figure 13. Contraceptive & Condom Shipment Values to Asia, Major Receiving Countries, FY 2015

- With 84 percent of all shipment values in the region, Pakistan received all methods except female condoms (see figure 13, table 5, and appendix 3).
- Despite the focus of support to Pakistan—Bangladesh and Myanmar were two countries in FY 2015 to request a significant increase in shipment values, compared to FY 2014 and FY 2013 (see figure 13 and table 5).
- Thailand and Laos requested small shipment values after no shipment requests in FY 2014, while Afghanistan showed a continued decline in requests as commodity procurement moved to the Afghanistan Reconstruction Trust fund (see table 5).
- Support to governmental programs declined to 57 percent of shipment values, because the Government of Pakistan took responsibility for procuring reproductive health commodities in FY 2015. USAID supported social marketing programs in Bangladesh, Laos, Myanmar, Nepal, Pakistan, and Thailand (see figure 14).
- The 10-year trend for program type reflects a decrease in social marketing programs in Bangladesh and a refocusing of support to the Pakistan governmental programs. For the first time since 2010, the governmental and social marketing program—supported shipments were nearly equal (see figure 15).



# Contraceptive and Condom Shipments to Latin America and the Caribbean

- In the LAC region, the recent trend of consistent support between \$3 million and \$4 million continued with \$4 million of shipments in FY 2015. The overall downward trend of shipment values during the past 10 years is because of the programs graduating from USAID support (see figure 16).
- Three countries in the LAC region requesting shipments in FY 2015 remained; in FY 2013, there were six countries (see table 6).
- The variety of methods shipped to LAC in FY 2015 decreased to three methods: male condoms, injectables, and oral contraceptives. No requests were made for implants or IUDs in FY 2015. Male condoms continued to account for the majority of shipment values to the region; Haiti requested the largest value and quantity of male condoms (see figure 17 and table 6).
- Haiti continued to request the largest shipment values in the region. Haiti received the entire value of oral contraceptives and most of the injectables and male condoms shipped to the region in FY 2015 (see figure 18 and appendix 3).
- In FY 2015, NGO programs were the largest program type supported in LAC, receiving 80 percent of FY 2015 shipment values. After showing a steady increase during the past two years, social marketing decreased to 20 percent of shipments. Support to governmental programs has diminished over the past 10 years, corresponding to the graduation of programs from USAID support (see figures 19 and 20).




### Contraceptive and Condom Shipments to Europe and Eurasia

- Shipment support to the E&E region has been sporadic during the past 10 years. After four years of consistent, but minimal, support to the region, FY 2015 saw an increase of the shipment values to the region (see figure 21).
- The number of methods shipped to the region increased from only contraceptive implants and IUDs in FY 2014 to include all methods except injectables and female condoms in FY 2015 (see figure 22).
- Georgia has been a steady recipient in the E&E region in recent years. Armenia was represented in FY 2013 with a small shipment of male condoms. For the first time since FY 2010, Ukraine requested a large order of male condoms in FY 2015, which more than doubled the region's shipment values during FY 2014 (see figure 23 and table 7). Placing large orders every few years is a typical ordering pattern for Ukraine; because of the long importation process, the mission orders product for multiple years at a time.
- With shipment requests from Ukraine in FY 2015, the NGO support accounted for 77 percent of shipment values (see figure 24)—a shift from FY 2014 when shipments were exclusively to governmental programs in Georgia. Historically, until FY 2011, shipments were primarily directed to NGOs when NGO support ended and considerably smaller shipments went to governmental programs (see figure 25).




# Contraceptive and Condom Shipments to the Middle East

- Shipments during the past 10 years to the Middle East have declined significantly, with minimal or no shipments since FY 2008. Again, the region did not request shipments in FY 2015 (see figure 26).
- During the past three years, Jordan was the only country in the region to request a small shipment of contraceptive implants in FY 2013 (see table 8).





Figure 27. Contraceptive & Condom Shipments by Program Type, to the Middle East, FY 2006–2015

- Historically, when support is requested from the region, it has been for governmental programs (see figure 27).

### Worldwide Oral Contraceptive Shipments

- The overall 10-year trend for oral contraceptive shipments continues downward, although FY 2015 had a slight increase over the FY 2014 shipment quantities (see figure 28).
- The total number of countries that ordered oral contraceptives increased by three from FY 2014 to FY 2015, with 24 countries ordering in FY 2015 (see table 9).
- The Africa region continued to request the largest amount of oral contraceptives; FY 2015 had very similar levels to the previous year. With large shipments to Pakistan, the Asia region showed an increase in shipment quantity and value. The LAC region also showed a slight increase in quantities and values in FY 2015 compared to FY 2014. After no shipments to the region in FY 2014, E&E had 1 percent of the shipments in FY 2015 (see figure 29 and table 9).
- Pakistan has been a major recipient of orals in the last five years; for the second year in a row, the country requested the most orals worldwide. After a decrease in quantity requested by Pakistan in recent years, FY 2015 showed the quantity more than double during FY 2014 (see figure 30 and table 9).
- Angola, Liberia, and Zambia showed increasing shipment quantities during the past three years, while Niger and Guinea each placed a request after two years of no shipments. Shipments of orals to Madagascar and Tanzania have declined since FY 2013 (see table 9).
- While Ghana, Malawi, Nigeria, Sierra Leone, Uganda, and Haiti show a significant shipment increase this year over last year; a look at three years of shipment totals does not show a specific trend in oral contraceptive shipments for these countries (see table 9).



### Worldwide Injectable Contraceptive Shipments

- The quantities of injectable contraceptives shipped during the past 10 years reflect an overall upward trend. FY 2015 showed an increase, compared to the previous two years, which had declining numbers (see figure 31).
- Consistent with the upward trend of total quantities of injectable contraceptives, the number of requesting countries rose to 24 in FY 2015, after remaining at 20 since FY 2013 (see table 10).
- For the third year in a row, only Africa, Asia, and LAC requested injectable shipments. As in FY 2014, Africa received the largest quantity in FY 2015—70 percent of all shipment values, followed by Asia and LAC (see figure 32 and table 10).
- Pakistan was again the country that requested the largest quantity and value in FY 2015, accounting for 17 percent of the worldwide injectable shipment values. Despite this, a smaller quantity and value was shipped to Pakistan in FY 2015 compared to FY 2014 and FY 2013 (see figure 33 and table 10).
- In FY 2015, Africa and the LAC regions both increased in overall quantity and value shipped, compared to FY 2014. The increase in Africa was because of a significant increase of orders from Kenya, Madagascar, Mozambique, Nigeria, Tanzania, and Zambia, compared to FY 2014. The increase in LAC was from a large order from Haiti and a small Honduras request, after two years with no orders of injectable contraceptives (see table 10).
- For the past three years, Angola, Ghana, Nigeria, and Tanzania have had increasing trends for injectable shipments. Ethiopia did not request any injectable shipments in FY 2015, after having a sizeable increase in FY 2014. Several country requests showed significant decreases in quantity and value for the past three years: Benin, Malawi, Mali, and Uganda (see table 10).
- The Asia region saw a decrease in FY 2015. The decrease in the Asia region was due to smaller shipment requests from Nepal and Pakistan, and no orders from Afghanistan. Despite the decline to the region, Bangladesh indicates an increasing three-year trend (see table 10).



### Worldwide Contraceptive Implant Shipments

- The quantity of contraceptive implants requested continued to show a dramatic upward trend, with a large increase in quantity shipped in FY 2014 over FY 2013, and again in FY 2015 over FY 2014 (see figure 34). The value of worldwide implant shipments increased by 43 percent over FY 2014 (see table 11).
- Despite the large increase from FY 2014, FY 2015 saw orders from 22 countries, a decrease from 23 countries in FY 2014 (see table 11).
- Similar to FY 2014, implant orders shipped to Africa accounted for 92 percent of the total value of all contraceptive implant orders in FY 2015. The Asia region had shipments only to Pakistan; the E&E region had one small shipment to Georgia. There were no shipments to the Middle East or Latin America regions (see figure 35 and table 11).
- Tanzania, Kenya, Pakistan, Senegal, and Zambia received the largest value of implant shipments in FY 2015, together accounting for 73 percent of values shipped worldwide (see figure 36).
- The Africa region has an increasing trend for quantities of implants shipped during the past four years; the increase over the past year is mostly due to a dramatic increase of requests from Tanzania for the Ministry of Health, which accounted for nearly half of the total worldwide requests in FY 2015 (see figure 36 and table 11).
- Madagascar showed the greatest percentage increase over FY 2014, although the order quantity remained on the smaller side compared to other countries. DRC, Kenya, Mozambique, Tanzania, Zambia, and Pakistan are showing an upward three-year trend, with increasing implant requests (see table 11).
- Despite the overall increase in shipments to countries worldwide, Ethiopia and Haiti indicate a downward trend in implant requests over the past three years (see table 11).



### Worldwide Intrauterine Device Shipments

- For the second year, IUD shipment quantities decreased over the previous year; however, the 10-year trend line continues upward (see figure 37).
- Even though FY 2015 saw a decrease in the quantity and value shipped, there was an increase in the number of countries placing order requests, compared to FY 2014. In FY 2015, 16 countries requested shipments, compared to 12 countries in FY 2014 (see table 12).
- In FY 2015, three of the four regions that requested orders in FY 2014 and FY 2013 requested IUDs; the LAC region did not place a request in FY 2015. Africa requested the largest percentage of shipment values, followed by Asia. E&E requested only 1 percent of shipment values, with Georgia as the only recipient in the region (see figure 38 and table 12).
- In FY 2015, Pakistan shipments accounted for 41 percent of total values for IUDs and the entire quantity shipped to Asia (see figure 39). This is a decrease of nearly one million units from FY 2014, when shipments to Pakistan represented 60 percent of the total demand for IUDs (see table 12).
- After a decrease in total quantities ordered in the past three years, the Africa region showed a sharp increase in FY 2015, with more than four times the quantity of orders in FY 2014. Several countries in Africa placed requests in FY 2015, after no requests in FY 2014. Additionally, Madagascar, Mali, and Mozambique significantly increased the quantity and value of their orders, compared to FY 2014. DRC, Liberia, Kenya, and Tanzania indicate increasing three-year trends (see table 12).
- As in FY 2013 and FY 2014, there was a small shipment to only one country in the E&E—Georgia; there were no shipments to LAC, as Haiti did not request an order in FY 2015 (see table 12).



### Worldwide Male Condom Shipments

- Male condom shipments increased slightly in value and quantity from the previous year. The FY 2015 quantity was the second largest in the past 10 years, with the overall trend continuing upward (see figure 40). The increase in recent years is because of the large shipments to Pakistan—more than 100 million annually since FY 2010.
- Consistent with the increase of quantities in FY 2015, the number of countries requesting shipments increased in FY 2015; 33 countries had male condom orders in FY 2015 compared to 27 in FY 2014 (see table 13).
- Four of the five regions requested shipments of male condoms in FY 2015: Africa, Asia, E&E, and LAC. Africa was the only region that showed a decrease over the prior year, but Africa still accounted for 52 percent of shipment values (see figure 41 and table 13).
- With an increase over FY 2014, Pakistan again requested the largest amount of male condoms in FY 2015; Zimbabwe, Haiti, Zambia, and Ethiopia followed with the largest values requested (see figure 42 and table 13).
- Burkina Faso, Mali, Senegal, South Sudan, Zimbabwe, and Myanmar show an upward trend with continuously increased condom shipments over the past three years. Swaziland had a large order request after not placing a male condom order in FY 2014 (see table 13).
- Tanzania was notable with no male condom orders in FY 2015, after significant quantities ordered the prior two years; while Ghana, Togo, and Uganda all have three-year declining trends (see table 13).
- After two years with no male condom orders, Cameroon, Mozambique, South Africa, and Laos requested shipments in FY 2015. Ukraine received more than 34 million male condoms, ordering for the first time in six years (see table 13).



## Worldwide Female Condom Shipments

- Female condom shipments for FY 2015 increased 17 percent over FY 2014. Although there are year-to-year variations, the trend for the past 10 years is increasing, with the most recent years showing a steady rise (see figure 43).
- In FY 2015, 14 countries requested female condoms, compared to nine countries in FY 2014 (see table 14).
- In FY 2015, only two regions requested orders; Africa accounted for 97 percent of shipments, while Asia accounted for the remaining 3 percent (see figure 44 and table 14).
- Zimbabwe again requested the largest value of shipments, receiving 60 percent of worldwide shipment values. Lesotho followed with 14 percent of worldwide shipment values in FY 2015, after two years without female condom shipments (see figure 45 and table 14).
- Although Tanzania requested the third largest values for the third year in a row and had 7 percent of the shipment values, the order trend is showing a decline during the past three years (see figure 45 and table 14).
- Togo, Swaziland, Zambia, and Zimbabwe saw significant increases in quantity and value for their country orders, as compared to FY 2014. There was no order request from DRC after large orders in FY 2014 (see table 14).
- After a year of no requests, the Asia region had requests from two countries: Laos and Myanmar. In FY 2015, Laos placed a small order of female condoms and Myanmar placed a larger order, although smaller than their previous request in FY 2013 (see table 14).


