

# Overview of Contraceptive and FP/RH Condom Deliveries

In fiscal year 2018 (FY 2018) USAID provided voluntary family planning and reproductive health (FP/RH) commodities through missions in Africa, Asia, Latin America and the Caribbean (LAC). There were no shipments in FY 2018 to Europe and Eurasia (E&E) or the Middle East.

In 1990, USAID created the Central Contraceptive Procurement Project – a centralized system to support global efforts to provide contraceptives. The system was administered by the Commodities Security and Logistics division of USAID's Office of Population and Reproductive Health (OPRH), which provides technical leadership, ensures quality of commodities, improves supply chain and logistics management in developing countries, and maintains a database for USAID commodity assistance. Missions determine the quantity and type of contraceptives needed for their family planning (FP) programming and place orders with the designated USAID supply chain procurement contractor.

USAID reports on contraceptive and condom shipments within a given FY. Although responsibility for commodities ends once they are delivered, previous editions of this report have focused on commodities that had been "shipped" to countries as opposed to those that were "delivered." This was due to challenges in timely processing of paper-based documents affirming delivery. Commodities "shipped" referred to commodities that had departed from the manufacturer or regional distribution center (RDC), while "delivered" referred to commodities that had reached their destination.

With increased accessibility of data online, reporting of delivered data is now possible.

Therefore, the focus of this report is on commodities that were delivered in FY 2018 and not commodities that were shipped. This change impacts only four shipments (2%) that were shipped at the end of FY 2017 and delivered in FY 2018. Data from this report has been meticulously reviewed to make sure no lines from last year's shipped dataset were double counted as delivered.

This updated approach is consistent with standard metrics used by USAID and other supply chains and allows for better comparisons that accurately reflect countries' receipt of commodities. For transitional purposes, the 10-year historical shipment trends will omit the oldest FY data points for each year that passes until only the delivered shipment trends are reflected. Commodities from the shipped data of FY 2017 and earlier are presented in this report alongside the analysis for the delivered data of FY 2018. Therefore, where 10-year trends are presented, all FY 2009-17 are historical shipped data and all FY 2018 are delivered data.

Management of condom procurement for USAID's Global Health programs shifted from the OPRH to the Office of HIV/AIDS (OHA) in 2017, and as such, this report only includes analysis on condoms procured with OPRH funds from FY 2017 onward. Condoms delivered through the U.S. President's Emergency Plan for AIDS Relief (PEPFAR) funding are not reported, as is reflected in the decreased number of male condoms, when compared to historical data that reflects PEPFAR and FP funded condoms. The overall U.S. government investment in condoms has not decreased and information on condoms funded through PEPFAR can be obtained from OHA.

There was an overall increase in total delivered value in FY 2018 driven by increases in value and quantities of implants and injectables. Africa was one of the main drivers behind this increase with a 30 percent increase in value accounting for 88 percent of total delivered value and six countries in the region that had significant increases in value.

This report is organized into three sections: worldwide overview by commodity type, USAID region, and by commodity type. Six commodity types were delivered in FY 2018, including:

- oral contraceptives
- injectable contraceptives
- contraceptive implants
- intrauterine copper devices (IUDs)
- male condoms
- standard days method

Female condoms were not delivered in FY 2018.

This report summarizes the FY 2018 delivered quantities and value of contraceptives and FP funded condoms, providing comparisons with FY 2017, and presents the 10-year trends from FY 2009-18.


### Worldwide Contraceptive and FP/RH Condom Deliveries

This section summarizes the delivered value and quantities for all contraceptives and condoms delivered in FY 2018 globally. The worldwide delivered values by region are discussed, followed by the delivered value and quantities by method and program type.

After two years of decline the total delivered value of contraceptives and condoms have increased in FY 2018 by 21 percent to \$51.5 million (see Exhibit 1). The upward trend is mainly driven by an increase in the Africa region which comprises almost 88 percent of delivered value and increases in contraceptive implants and injectable contraceptive delivered values and quantities. Ethiopia, Ghana, Kenya, Nigeria, Rwanda, and Tanzania made substantial procurements of implants reflecting the global movement towards long acting and reversible contraception (LARCs). Condoms funded through OPRH have declined due to the shift in the management of condom procurement to OHA in FY 2017 as noted above.

In FY 2018, Africa accounted for the largest amount of delivered value of contraceptives and condoms accounting for 88 percent of worldwide shipments,

Exhibit 1. Trends in Worldwide Contraceptive and FP/RH Condom Delivered Values, FY 2009-18<sup>1</sup>



followed by Asia (9 percent), and Latin America and the Caribbean (3 percent, see Exhibit 2). For the second year in a row there were no shipments to Europe and Eurasia and the fourth year in a row the Middle East did not have any shipments. For quantities shipped by region see Annex A.

Contraceptive implants and injectables combined made up almost 90 percent of the total delivered value with 46 percent and 41 percent, respectively, which can be attributed to the popularity and higher price per unit cost of these methods. The use of implants and injectables, long-acting reversible methods, are increasing globally. Additionally, contraceptive implants use is rising rapidly in many sub-Saharan African countries across almost all socio-demographic categories which accounted for 99 percent of the total delivered value for implants. Several factors are behind this increase including greater country commitment to ensure access to a wider choice of methods such as implants; the method has many positive characteristics such as its effectiveness, is long lasting and reversible, can be quickly inserted, and has a high client satisfaction

rate; revised guidelines on who can use implants; significant reduction in commodity cost and availability; and improved service delivery practices such as tasking shifting to lower-level providers<sup>2</sup>.

The values and quantities of implants and injectables are higher than FY 2017 levels. This was followed by oral contraceptives (10 percent), male condoms (2 percent), and standard days methods (1 percent). Intrauterine devices made up a very small proportion (0.33 percent) (see Exhibit 3) of the total value. There were no female condom shipments in FY 2018. Only male condoms funded through OPRH are reported here and not PEPFAR funded condoms.


Africa was the only region that had an increase in the value of deliveries by 30 percent while Asia and LAC continued a downward trend in value (see Exhibit 4). Africa's absolute value increased by \$10.5 million between FY 2017 and FY 2018. This can be attributed to significant increases in value by DRC (105 percent), Ghana (278 percent), Kenya (298 percent), Madagascar (185 percent), Rwanda (222 percent), and Togo (392 percent) coupled with 13 countries procuring between \$1 - \$9 million in commodity value. Countries like DRC, Kenya, Madagascar place big orders once a year and then tend to include buffer stocks to account for delays from in-country processes.

Overall worldwide delivered values increased by 21 percent. The shift in values reflects the global shift towards LARC methods. Contraceptive implants

increased by 86 percent, injectable contraceptives by 44 percent, and IUDs by 51 percent (see Exhibit 5). This reverses a downward trend from FY 2016-17 for these three methods. This dip was potentially caused by countries bringing stock levels up in anticipation in a shift of procurement agents.

Therefore, FY 2018 may be showing a resumption of more regular ordering patterns. For male condoms and oral contraceptives, the decreases continued. Again, male condom procurement has shifted to OHA and this decrease does not reflect an overall decline for male condoms, just those funded with family planning funds. Coupled with greater commitment from governments to expand method choice and high impact service delivery practices, this has resulted in increased demand for longer acting methods such as implants and injectables, which drive the overall value of contraceptives delivered.



In parallel with the increase in delivered value, the quantities of contraceptive implants increased by 47 percent, injectable contraceptives by 47 percent, and IUDs by 51 percent, which may be a reflection of ordering patterns stabilizing. Oral contraceptive quantities decreased by 25 percent (see Exhibit 6).

Government programs received 54 percent of worldwide contraceptive and FP/RH condom delivered value in FY 2018 (see Exhibit 7). Social marketing and non-governmental organizations NGO's shared approximately a quarter each of the remaining delivered values with 24 percent and 22 percent, respectively.

While the delivered value to government programs continue to increase and make up the largest proportion among the programs, support to NGOs

showed a significant increase of 586 percent in FY 2018 when compared to FY 2017 but is not attributable to increase in the number of recipient NGOs (see Exhibit 8). In contrast, social marketing

programs had a 38 percent decrease in delivered value in FY 2018. Part of this decrease may be attributed to countries who previously made large procurements for social marketing programs have now stopped placing them through USAID. Additionally, social marketing programs have traditionally placed large orders of oral contraceptives. Now that the shelf-life of oral contraceptives have reduced from a 5-year to a 3-year shelf life due to changes in packaging design, the result is social marketing programs holding less inventory and reducing the quantities ordered.

Exhibit 9 supplements Exhibit 7 by providing the disaggregated delivered value by method for each program type.




# Contraceptive and FP/RH Condom Deliveries to Africa

Overall, the number of country requests from Africa decreased from 22 countries in FY 2017 to 19 countries in FY 2018, however, the delivered value increased by 30 percent driven mainly by increases in contraceptive implants and injectables (see Exhibit 10). The value of deliveries to Africa in FY 2018 totaled \$45.3 million.

Implants accounted for the largest delivered value (51 percent) followed by injectable contraceptives (34 percent), oral contraceptives (12 percent), male condoms and standard days methods (both 1.4 percent), and IUDs (0.4 percent) (see Exhibit 11).


In total 19 countries requested commodities in FY 2018. This is the third year in a row where there were fewer country requests than in previous years (22 in FY 2017 and 29 in FY 2016) but the delivered value still increased in FY 2018 in Africa. The reduction in countries could be attributed to the larger trend of fewer countries procuring through USAID and using their own funding mechanisms or other procurement agents or a lack of sufficient funding to procure commodities.

Exhibit 10. Trends in Contraceptive and FP/RH Condom Delivered Values to Africa, FY 2009-188




Five African countries made up 55 percent of the total delivered value in the region. The top five receiving countries were Uganda (21 percent), Ghana (11 percent), Malawi (9 percent), Madagascar (8 percent), and Nigeria (7 percent) (see Exhibit 12). The other 11 countries accounted for the remaining 45 percent in terms of delivered value.

Exhibit 12. Contraceptive and FP/RH Condom Delivered Values to Africa, Major Receiving Countries, FY 2018



Government programs accounted for 59 percent of total delivered value of commodities to the Africa region in FY 2018, an increase of 47 percent from FY 2017. This was followed by NGOs (25 percent), and social marketing (16 percent) (see Exhibit 13). The delivered value going to NGO's increased by 586 percent from FY 2017 while social marketing's value decreased by 52 percent (see Exhibit 14). The changes could be partially attributed to the increase in implants where governments are traditionally the distributors of these methods and the decrease in oral contraceptives and condoms which are socially marketed.

Togo, Kenya, and Ghana had large increases of 392, 298, and 278 percent respectively while Benin had a decrease of 98 percent (see Exhibit 15).

Nigeria was the only top five receiving country where its delivered value decreased by 18 percent in FY 2018. All of the other top receiving countries increased the value of deliveries.

In FY 2017, five countries placed orders but not in FY 2018: Burkina Faso, Cote d'Ivoire, Eswatini, Niger, and Zimbabwe (see Exhibit 15). Zimbabwe (not a PRH-priority country) does not procure FP/RH funded condoms, but PEPFAR funded condoms under OHA. Cameroon and Guinea placed orders in FY 2018 but previously did not in FY 2017. There are five countries that did not place an order in either FY 2018 or FY 2017: Angola, Cape Verde, Chad, South Africa and South Sudan. For the quantities of each method delivered by country see Annex B.

Exhibit 14. Trends in Contraceptive and FP/RH Condom Delivered Values by Program Type to Africa, FY 2009-189




### Contraceptive and Condom Deliveries to Asia

The total contraceptive and condom delivered value to Asia in FY 2018 was \$4.9 million, continuing a decline in value since FY 2015 (see Exhibit 16). This reflects shifting USAID FP/RH investments in Asia towards technical assistance and is also a result of Pakistan assuming responsibility for procuring its own contraceptives. The number of countries ordering commodities decreased from four countries in FY 2017 to two in FY 2018. Seventy-six percent of the value of contraceptives went to Bangladesh. Social marketing programs were the recipients for a majority of the commodities.

Injectable contraceptives represented 93.3 percent of the delivered value to Asia in FY 2018 (see Exhibit 17). Male condoms (4 percent), contraceptive implants (2.6 percent), and IUDs (0.1 percent) made up the rest (6.7 percent). Oral contraceptives and standard day methods were not shipped to Asia in FY 2018.


Only two countries, Bangladesh and Nepal, accounted for all of the deliveries to Asia in FY 2018 (see Exhibit 18). Bangladesh made up 76 percent and Nepal 24 percent of the delivered value.

Exhibit 16. Trends in Contraceptive and FP/RH Condom Delivered Values to Asia, FY 2009-18<sup>11</sup>




Although there was a decrease overall in delivered value for Asia by 16 percent, both Bangladesh and Nepal had increases in value by 35 percent and 13 percent respectively (see Exhibit 19). Both


countries had increases in value of injectable contraceptives. Nepal ordered implants in FY 2018 but did not in FY 2017.

There were two countries who placed an order in FY 2017 but did not do so in FY 2018 (Afghanistan and Tajikistan). There were three countries who did not place orders in FY 2017 or FY 2018 (Kazakhstan, Pakistan, and Papua New Guinea). Pakistan is procuring its own contraceptives and no longer relies on USAID.

Social marketing and governments were the only programs who received commodities in FY 2018, with 82 percent and 18 percent, respectively (see Exhibit 20). This was similar to last year where social marketing received the greater portion, with only a 3 percent increase in FY 2018, reflecting government's commitment to funds FP commodities and USAID' shifting FP/RH strategy in this region from commodities to more support towards technical assistance.

The delivered value to government programs in Asia has continued to decline (primarily because of Pakistan procuring its own commodities) while social marketing programs have remained steady since 2016 (see Exhibit 21).

Exhibit 21. Trends in Contraceptive and FP/RH Condom Delivered Values by Program Type to Asia, FY 2009-18<sup>12</sup>




Exhibit 19. Total Value of Contraceptive and FP/RH Condom Delivered to Asia by Country, FY 2016-18<sup>13</sup>



# Contraceptive and FP/RH Condom Deliveries to Latin America and the Caribbean

The total delivered value for LAC was \$1.3 million in FY 2018 (see Exhibit 22). Because of the transition away from USAID programming, the downward trend continued in the LAC region with a decrease by 34 percent in FY 2018. Haiti accounted for all contraceptives with all commodities going to social marketing programs.

Injectable contraceptives made up the majority (81.3 percent) of the delivered value in the LAC region. Contraceptive implants accounted for 12.1 percent, followed by oral contraceptives with (6.5 percent), and IUDs with 0.1% (see Exhibit 23).

Exhibit 22. Trends in Contraceptive and FP/RH Condom Delivered Values to LAC, FY 2009-18<sup>14</sup>




A decrease of 34 percent of total delivered value occurred in the LAC region in FY 2018 (see Exhibit 24).

Exhibit 25 shows the value of deliveries to Haiti. The largest value of deliveries for Haiti were injectable contraceptives (\$1.1 million) followed by contraceptives implants (\$158,980), oral contraceptives (\$85,977), and IUDs (\$1,824).

Social marketing accounted for all deliveries in FY 2018 and none went to government programs or NGOs (see Exhibits 26 and 27).



Exhibit 25. Total Value of Contraceptive and FP/RH Condoms Delivered to LAC by Country and Method, FY 2018




### Worldwide Implant Contraceptive Shipments

After two-years of decreases, the quantity and value of contraceptive implants increased in FY 2018 (see Exhibit 28). The total delivered value of contraceptive implants was \$23.4 million in FY 2018, an increase of 86 percent and continuing a general upward trend since 2012 when the minimum volume guarantee began. The Africa and LAC regions quantity and values increased while those decreased in Asia. In total 19 countries requested implants, making it the contraceptive with the highest number of countries who procured the product and also accounted for the largest total value among all contraceptives. There were 16 countries from Africa, two from Asia (Bangladesh and Nepal), and only Haiti from the LAC region (see Exhibit 31).

Africa accounted for 98.8 percent of the delivered value of contraceptive implants in FY 2018 with LAC and Asia making up 1.2 percent of the remaining amount (see Exhibit 29).

The five largest receiving countries accounted for a total of 66 percent of the delivered value (see Exhibit 30).


Exhibit 28. Trends in Worldwide Contraceptive Implant Delivered Quantities, FY 2009-18<sup>16</sup>


They were Uganda (20 percent), Ethiopia (13 percent), Kenya (13 percent), Tanzania and Nigeria (both 10 percent). The other 14 countries made up the remaining 34 percent.

Overall there was a 47 percent increase in quantities and an 86 percent increase in delivered value from FY 2017 reversing a two-year downward trend (see Exhibit 31). All the top five receiving countries' quantities and values increased except Ethiopia. Its quantities decreased by 26 percent, but the delivered value increased by 156 percent. Ethiopia has received implants kits from both USAID and UNFPA. Malawi, Uganda, and Rwanda had increases in quantity and value ranging from 439 percent to 691 percent. This trend reflects greater government commitment to expand method choice, and wider adoption of high-impact service delivery practices that broaden access and better reach to underserved populations. Mali, Bangladesh, and Mozambique had large decreases in quantity and value. Availability of funding from these countries has been part of the reason. Although there were only four additional countries that ordered

contraceptive implants in FY 2018, the absolute value increased by \$10.8 million dollars or 86 percent in FY 2018.

Niger ordered implants last year but not in FY 2018. The DRC, Liberia, Togo, Zambia, and Nepal did not order in FY 2017 but did in FY 2018, most likely because USAID stepped in to fund the procurement of this method. Five countries, Burkina Faso, Chad, Cote d'Ivoire, Guinea, and Pakistan have not placed orders in the last two years. We know that a country like Burkina Faso is increasing the implants' share in the method mix where implants are the most widely used method, accounting for nearly half (48.1 percent) of all modern method use. Burkina Faso's procurement of implants was most likely supported by UNFPA and through domestic fund


#### Worldwide Injectable Contraceptive Shipments

Overall the delivered value of injectable contraceptives to 16 countries was \$21 million (see Exhibit 32). There was an increase in the number of countries, delivered value, and quantities reversing a two-year downward trend. All three regions had increases in quantity and delivered value in FY 2018 from FY 2017. Injectables had the second largest number of countries ordering this product and had the second highest total delivered value among all contraceptives. However, the procurement pattern for injectable contraceptives has shown three years of decreases since 2015 as countries drew down on their inventory followed by an increase to bring stock levels back up in FY 2018.

Similar to last year, Africa, Asia, and LAC were the only regions requesting injectable contraceptives (see Exhibit 33). Following the same trend from last year Africa received the largest proportion by value in FY 2018, with 73 percent, followed by Asia (22 percent), and LAC (5 percent).

The five largest receiving countries by value were nearly the same as last year, Uganda, Bangladesh,


Exhibit 32. Trends in Worldwide Injectable Contraceptive Delivered Quantities, FY 2009-18<sup>18</sup>

Malawi, and Madagascar with the exception of Ghana replacing Nigeria in FY 2018 (see Exhibit 34). These countries accounted for 68 percent of the total delivered value of injectable contraceptives in FY 2018. The first four countries also had increases in delivered value from FY 2017. Madagascar (176 and 121 percent) and Mozambique (206 and 156 percent) had large increases in quantity and value. Nigeria received a large order in FY 2017 and most likely had sufficient stock in FY 2018 which could be the reason for the decrease in quantities ordered in FY 2018.

A total of 16 countries ordered injectable contraceptives which was an increase compared to 13 countries in FY 2017 and this was the same number (16) from FY 2016 (see Exhibit 35). Although there were 16 countries who ordered in both FY 2018 and FY 2016, the delivered value increased by \$4.8 million in FY 2018.

Overall quantities and delivered value increased in FY 2018 by 47 percent and 44 percent, respectively, reversing a downward trend from FY 2015 to FY 2017. This was mainly driven by increases across all three regions with Africa increasing by 64 and 55 percent in quantity and value, Asia by 17 and 21 percent, and LAC by 12 and 20 percent. The amount of quantities and value increased for all

countries except Nigeria which decreased by 81 percent in both quantity and value. Liberia had a very minor decrease in quantity and increase in value.

Cameroon is a new country who had not previously ordered injectable contraceptives in FY 2016-FY 2017. Brazil, Ghana, and Guinea did not place any orders in FY 2017 but did in FY 2018. Afghanistan was the only country who had ordered injectable contraceptives in FY 2017 but did not in FY 2018. There were five countries who have not placed an order in at least two years: Angola, Rwanda, Senegal, Togo, and Pakistan.


#### Worldwide Oral Contraceptive Shipments

An overall downward trend since 2011 for oral contraceptive quantities continued with a decrease in delivered value by 23 percent (see exhibit 36) which supports the global trend towards LARCs. Africa and the LAC received all of the oral contraceptives in FY 2018 with a total delivered value of \$5.4 million going to 15 countries. Oral contraceptives had the third largest number of countries procuring this product behind implants (19 countries and injectable contraceptives with 16 countries).

Africa continues to dominate requests for oral contraceptives increasing their share in terms of value to 98 percent from 83 percent in FY 2017 (see Exhibit 37). The LAC percentage decreased to 2 percent from 3 percent in FY 2017 and Asia did not request any this year while their share last year was 14 percent.

A total of 15 countries requested oral contraceptives comprised of 14 countries from Africa and one from LAC (Haiti). This was an increase of one country from FY 2017. The Asia region requested oral contraceptives in FY 2017 but did not in FY 2018.


Exhibit 36. Trends in Worldwide Oral Contraceptive Delivered Quantities, FY 2009-18<sup>20</sup>


Zambia, Mozambique, Uganda, Ghana, and Madagascar received similar proportions of oral contraceptives ranging from 12 to 15 percent (see Exhibits 38 and 39). Together these five countries made up 68 percent of the value of requested oral contraceptives. Ten other countries made up the remaining 32 percent.

The procurement of oral contraceptives continued an II-year downward trend due to expanded access to other methods such as LARCs. The quantities for FY 2018 of 16,800,080 was lower than last year's which at that point was the lowest quantity in a I0-year period (see Exhibit 39). There was a 25 percent decrease worldwide of oral contraceptive quantities and a 23 percent decrease in value. Mali, Nigeria, Tanzania, and Uganda had significant decreases in quantity and value. Ghana, Zambia, and Malawi's quantities and value increased, ranging from I34 percent to 267 percent.

Haiti was the only country outside of the Africa region which received deliveries of oral contraceptives, but their quantities and value decreased from FY 2017 to FY 2018 by 60 percent and 59 percent respectively.

Guinea, Liberia, Madagascar, and Rwanda ordered oral contraceptives in FY 2018 after not ordering in FY 2017. Countries who ordered in FY 2017 but did not order in FY 2018 were Afghanistan, Benin and Burkina Faso. Countries who did not order in either FY 2018 or FY 2017 were Angola, Senegal, and Pakistan. This reflects the adjustment in supply chain ordering patterns related to the reduction of shelf-life with packaging change from PVC to ACLAR. Finally, many countries may have sufficient stock of this method from orders dating from previous years or maybe procuring through other procurement agents.

# Worldwide Male Condom Shipments

As noted previously only condoms procured for family planning are reported here. The management of condom procurement has transitioned from OPRH to OHA and, therefore, condoms shipped through PEPFAR are not part of this report. Please note that FY2017-2018 data reflects only FP funded male condoms, while FY 2016 and prior reflects FP and PEPFAR funded male condoms. This accounts for the significant downward trend in male condom quantities presented in the historical shipment trend (see Exhibit 40). In comparing FY 2017 to FY2018 there was a decline in FP funded male condoms. The total delivered value of male condoms in FY 2018 was \$812,000 with condoms going to four countries in the Africa and Asia regions.

In FY 2018, 76 percent of the delivered value went to the Africa region, followed by Asia with 24 percent (see Exhibit 41).

Rwanda had the largest delivered value with 38 percent, followed by Nepal (24 percent), Ghana (21 percent), and Madagascar (17 percent) (Exhibit 42).

Both the Africa and Asia regions had significant decreases in quantities and value. Rwanda and Nepal were the only two countries that ordered in FY 2017 and FY 2018. While both of their quantities decreased, Rwanda's value remained almost the same (see Exhibit 43). A total of 16 countries ordered male condoms in FY 2017. Ghana and Madagascar did not place an order in FY 2017 but did in FY 2018. A total of 14 countries who ordered male condoms in FY 2017 did not order any in FY 2018<sup>22</sup>. There are 15 countries who have not placed

an order in the last two years<sup>23</sup> mainly due to the shift of condom procurement to OHA.

# Exhibit 40. Trends in Worldwide Male Condom Delivered Quantities, FY 2009-18<sup>24</sup>





Exhibit 41. Male Condom Delivered Values by Region, FY 2018





### Worldwide Standard Days Method Shipments


The total delivered value of standard days methods to four countries in FY 2018 was \$612,000. Along with male condoms, this method had the smallest number of countries procuring this product.

Africa was the only region which ordered standard days methods in FY 2018 (see Exhibit 44). A total of four countries from Nigeria, DRC, Tanzania and Benin comprised a delivered value of \$611,967. Nigeria and the DRC made up 95 percent of the delivered value with 48 percent and 47 percent, respectively. In the past Nigeria places large orders of this product approximately every other year. Tanzania (5 percent) and Benin (0.3 percent) accounted for the remaining amount.

Although Nigeria had the highest delivered value, the DRC had more quantities delivered among the four countries (see Exhibit 45). This can be

attributed to the cost of shipping the products by air, due to the relatively small quantities.


# Worldwide Intrauterine Device Shipments

Although there was a slight increase in IUDs in FY 2018 after a steady decline began in FY 2014 (see Exhibit 46), this may be a pattern of stabilization after Pakistan shifted to procuring its own products and as countries draw down on existing inventory. The total delivered value of IUDs to eight countries in the Africa, Asia, and LAC regions was \$171,000 in FY 2018. This contraceptive made up the smallest total delivered value among all contraceptives which corresponds with this traditionally low volume and low demand product.

In FY 2018 Africa accounted for 94 percent of IUD delivered value followed by Asia (5 percent), and LAC (1 percent) (see Exhibit 47). This was the first time a LAC country ordered IUDs since FY 2015. A total of eight countries (six from Africa, Bangladesh and Haiti) ordered IUDs in FY 2018 compared with seven in FY 2017 (see Exhibit 49).

The five major receiving countries comprised 87 percent of the delivered value. Mozambique accounted for 40 percent while the four other major receiving countries, Senegal, Madagascar, DRC, and Mali accounted for approximately 10 – 13

Exhibit 46. Trends in Worldwide Intrauterine Copper Device Quantities, FY 2009-18<sup>26</sup>



percent each (see Exhibit 48). The remaining three countries (Guinea, Bangladesh, and Haiti), made up the remaining 13 percent.


The quantity and value of IUDs both increased by 51 percent from the previous year (see Exhibit 48). Only three countries who ordered in FY 2017 also ordered IUDs in FY 2018: Mali, Mozambique, and Bangladesh. Mali's quantities increased by 43 percent and Mozambique's by 118 percent and Bangladesh ordered the same amount as FY 2017.

Five countries, DRC, Guinea, Madagascar, Senegal, and Haiti ordered in FY 2018 but not the previous year. Four countries, Ghana, Kenya, Malawi, and Nigeria ordered in FY 2017 but not in FY 2018.

Six countries have not ordered in two or more years: Cote d'Ivoire, Liberia, South Africa, Zambia,

Nepal, and Pakistan. Unlike other contraceptives IUDs have a longer shelf-life and the consumption of this product is slower than other methods due to the length of couple-years of protection provided which may partly contribute to the lower number of countries procuring from year to year.

The following provides a summary and highlights from the FY 2018 Contraceptive and Condoms report:

- Overall total delivered value for contraceptives and condoms increased by 21 percent to \$51.5 million in FY 2018 from \$42.6 million in FY 2017 with the total number of countries ordering in FY 2018 increasing to 23 countries from 22.
- Contraceptive implants and injectable contraceptives:
  - Were the main drivers behind the overall increase in delivered value and in terms of absolute value, increasing by 86 percent and 44 percent respectively from FY 2017.
  - These two methods had the highest values and together accounted for 86 percent of the total delivered value
  - Nineteen and 16 countries, respectively, out of 23 countries ordered these methods making them the most requested commodities. In FY 2017, 13 and 9 countries, respectively, placed orders.
  - These trends support the global shift towards LARC methods
- Africa's delivered value increased by 30 percent or \$10.5 million.

- Africa continued to receive the majority of all methods worldwide accounting for 88 percent of the total delivered value. In FY 2017 Africa accounted for 82 percent of total shipped value.
- Asia's delivered value decreased again in FY 2018 by 16 percent, reflecting USAID shift towards technical assistance in this region as governments' funds are made available for procurement of commodities.
- With many LAC countries graduating from USAID the LAC regions delivered value decreased by 34 percent
- Injectable contraceptives were the highest delivered value method for Asia and the LAC region
- Oral contraceptives and male condoms continued downward trends while IUDs had an increase after two years of decreases.
- While government programs remain the largest recipient of commodities, there was a shift to NGO's in FY 2018 with an increase in delivered value to \$11.2 million in FY 2018 (from \$1.6 million in FY 2017) and a subsequent decrease to \$12.4 million in FY 2018 (from \$20.2 million in FY 2017) to social marketing programs.
