## Morocco: Civil Society Organizations Engaging the Government

USAID/Morocco, through the Office of Local Sustainability's (E3/LS) <u>Local Works</u> program,

has built relationships with five civil society organizations (CSOs) based on trust, shared interests, and mutual understanding. These groups have begun advocating together for legislation that would improve the operating environment for civil society. For example, they are advocating for an non-governmental organization law that transfers approval powers for CSO registration from the Ministry of Interior to the courts, thus de-politicizing the registration process and opening space for civil society participation. The groups are also collaborating to create a non-profit tax status so that local organizations are no longer treated as private companies. One of the groups, ALCI, was recently selected as a member of the National Steering Committee for the Open Government Initiative (OGI). In June 2019, the Ministry of Finance invited several CSOs to discuss ways to improve citizens' and civil society's inclusion in the budget process, and the leader of one, Forum Azahrae, was appointed by the King of Morocco to be a member of the National Council for Human Rights. USAID/Morocco is continuing to shift its programming towards an increasingly locally led development approach.

The project provided technical training on cacao processing and business management, and the SPA grant covered the cost of labor and building materials needed to convert an existing building into the new cacao processing center. This center is now fully operational, and the community has the training and capacity to run it independently. More than 100 families are now connected to and/or benefiting from the project by producing cacao and the community is working toward increasing the sustainability of its cacao businesses.

# Colombia: Tax Policies and Civil Society

Through E3/LS co-created research initiative Facilitating Financial Sustainability, LINC and the Colombia Action Learning Group (ALG) hosted a two-day workshop earlier this month on recent changes to local taxation policy and its implication for CSOs working in Montes de Maria. Sixteen grassroots organizations in this region comprise the Colombia ALG, which formed in October

2018 to identify and address systemic barriers to financial sustainability. This workshop was the first in a series of activities prioritized by the group to promote the long-term financial sustainability of CSOs.

#### From the Field

- In collaboration with the Hanoi government's Department of Natural Resources and ICLEI
   - Local Governments for Sustainability, a global network of local and regional
   governments committed to sustainable urban development, Live & Learn, a
   USAID/Vietnam <u>Local Works</u> implementing partner, co-organized a day-long workshop on
   "Mobilizing Green Initiatives for Hanoi." The event brought together representatives from
   the Hanoi government, international experts from Korea and the Philippines, NGOs,
   academics, and donors to mobilize and share practical solutions for addressing
   environmental protection and climate change.
- E3/LS supported stakeholder consultations with local network members under USAID/Vietnam's Local Works implementing partners, Live & Learn and Institute of Population, Health and Development (PHAD). E3/LS, Live & Learn, and PHAD worked together to develop a systems map of the environmental health/pollution space to better inform new project and activity designs. They also helped the Mission to integrate locally led development principles and gender equality into a follow-on Local Works award to reduce air pollution with Live & Learn.
- USAID/Morocco's <u>Local Works</u> lead contact is on a peer exchange with USAID/Dominican Republic this month to support USAID/Dominican Republic's Local Works program with attention to innovative procurements and sharing Morocco's locally led experiences.
- To leverage local experience and expertise, USAID/Dominican Republic has started a
  partnership with returned Peace Corps Volunteers. One Volunteer, with experience in
  community engagement, is working in the border region to provide capacity building and

technical assistance for the <u>Local Works</u> program.
