

### **KEY DEVELOPMENTS**

- On March 7, the fifth Ministerial Friends of Yemen meeting was held in London.
   Foreign ministers and delegations from approximately 30 countries attended the meeting, including U.S. Department of State Deputy Secretary William Burns. Meeting participants discussed a number of topics, including the need for continued humanitarian support for IDP and refugee populations. The 2013 YHRP requests \$716 million and aims to provide assistance to 7.7 million vulnerable people in Yemen.
- USAID/OFDA recently provided nearly \$4 million to support health, nutrition, and WASH interventions through partner Save the Children/U.S. (SC/US). These activities will reach more than 81,000 beneficiaries in both northern and southern Yemen, including Al Hudaydah, Sa'dah, and Ta'izz governorates.
- In 2013, Yemen has received nearly 18,000 new refugees, most of whom are of Somali or Ethiopian origin, according to UNHCR. State/PRM recently provided \$2.6 million in additional funding to an implementing partner to provide health care, WASH support, and capacity building assistance for Yemeni conflict victims.

#### POPULATION DISPLACEMENT AND HUMANITARIAN ACCESS

- Since July 2012, improved security conditions in southern Yemen have enabled nearly 140,000 IDPs to return to Abyan Governorate, reducing the total number of remaining IDPs registered in the south to approximately 30,000 people. Although returnees have received basic shelter support, household items, and food assistance, UNHCR reports an urgent need for assistance to restore damaged infrastructure and key services to ensure sustainable returns. With \$2.6 million from USAID/OFDA, Mercy Corps has distributed more than 7,000 relief commodity and hygiene kits to approximately 35,000 IDPs and host community members in Abyan and Lahij governorates since mid-December.
- Despite improved overall stability in southern Yemen, new outbreaks of fighting in parts of the region have resulted in small-scale displacement, according to the U.N. In February, clashes between Republic of Yemen Government (RoYG) forces and armed groups temporarily displaced more than 5,000 individuals from Al-Khubr district, Abyan Governorate, while fighting from late January to early February displaced thousands of other individuals in Al Bayda' Governorate—many of whom remain displaced. The International Organization for Migration (IOM), several non-governmental organizations (NGOs), and State/PRM-supported UNHCR have provided food, basic household supplies, shelter materials, and hygiene kits to both displaced and host families.
- Security concerns, damage to homes and infrastructure, and lack of basic services continue to hinder IDP returns in northern Yemen. UNHCR reports fewer than 40,000 IDP returns as of February 1, with nearly 320,000 people still displaced in the northern governorates of Al Jawf, Amran, Dhamar, Sa'dah, and Sana'a. Approximately 95 percent of IDPs in the north reside outside of established camps, primarily with host communities or in informal settlements.
- State/PRM recently contributed more than \$5.5 million to UNHCR for programs targeting refugee and IDP
  populations in Yemen. UNHCR will provide shelter, health care, education, and protection assistance to support
  refugee populations, as well as camp coordination and management, shelter, protection, and early recovery assistance to
  support IDPs and returnees.

### **FOOD SECURITY**


- Although food security in Yemen improved in 2012, 10.5 million people remained food insecure as of February.
   According to the U.N. World Food Program (WFP), the country's food security is anticipated to deteriorate in the first half of 2013 due to poor agricultural production, continued internal conflict, limited or fragile livelihoods, and increased international food prices.
- On February 8, WFP publicly released the Protracted Relief and Recovery Operation (PRRO) for 2013/2014, which aims to provide 10,000 metric tons (MT) of emergency food assistance to benefit nearly 131,000 people, including new refugee arrivals, refugees hosted in the Kharaz refugee camp in southern Yemen, and existing urban refugees. UNHCR forecasts 45,000 new arrivals to Yemen's coastal areas in the coming year, adding to the current caseload of more than 238,000 refugees. WFP will provide emergency food assistance to the majority of new arrivals at three reception centers established along the coast.
- Mercy Corps is currently implementing a \$4.7 million USAID/FFP emergency food program that will benefit
  vulnerable households in Dhubab and Mawza districts, Ta'izz Governorate. The project provides vouchers that
  beneficiaries can use to purchase food commodities available in local markets and will benefit more than 75,000
  individuals.

#### **HEALTH, NUTRITION, AND WASH**

Unrest across much of Yemen continues to hinder access to essential public services for more than 13 million Yemenis, according to the U.N. To increase access to essential WASH services and improve health care provision, USAID/OFDA partner Mercy Corps recently completed water rehabilitation projects at two health clinics in Al Kood village, Abyan Governorate. These clinics, including a mother and child health center, serve an estimated 5,000 households throughout the area.

- In response to elevated humanitarian needs in southern Yemen, USAID/OFDA partner Global Communities recently began implementing WASH trainings for community hygiene promoters in Khanfar, Lawdar, and Zinjibar districts in Abyan Governorate. In February, Global Communities also selected recipients for cash assistance to support the purchase of commodities in local markets in Aden and Lahij governorates.
- Approximately 1 million individuals in Yemen face global acute malnutrition (GAM) rates above the U.N. World
  Health Organization (WHO) emergency threshold of 15 percent countrywide, according to UNICEF. With support
  from USAID/OFDA, International Medical Corps (IMC) is currently conducting large-scale community-based
  management of acute malnutrition campaigns in three districts of Sana'a Governorate. Community health workers and
  district-level health officers are providing screening and referral services in 115 villages for malnourished children and
  pregnant or lactating women. IMC plans to reach 3,500 households through district hospitals, stabilization centers, and
  other health facilities.
- In February, WFP released the findings of a recent set of nutrition surveys, which found that levels of malnutrition have deteriorated in most of Yemen's governorates since the U.N.'s 2012 Comprehensive Food Security Survey. Humanitarian agencies and the RoYG conducted the surveys in governorates with historically high malnutrition rates, including Aden, Al Hudaydah, Hajjah, Ibb, Lahij, Raymah, and Ta'izz. With more than \$1.1 million in support from USAID/OFDA, SC/US will implement nutrition activities in Al Hudaydah, Sa'dah, and Ta'izz governorates targeting approximately 46,000 individuals, primarily children under five years of age and pregnant or lactating women.

### **CONTEXT**

- Since 2004, conflict between the RoYG and al-Houthi opposition forces has affected more than 1 million people
  and repeatedly displaced populations in northern Yemen, resulting in the need for humanitarian assistance. In
  addition, increased fighting between RoYG military forces and tribal and militant groups in the wake of the Arab
  Spring limited the capacity of the RoYG to provide basic services, exacerbated deteriorating humanitarian
  conditions among impoverished populations, and resulted in displacement in northern, central, and southern
  Yemen.
- Recent political instability and economic crisis, rising fuel and food prices, high levels of unemployment, conflict, and conflict-related displacement have left nearly half of Yemen's 24 million people food insecure. According to WFP, child malnutrition levels in the country are among the highest in the world, with 1 million children nationwide suffering from acute malnutrition.
- The overall security situation has improved in southern Yemen since renewed conflict broke out in 2009, facilitating the return of 140,000 IDPs to areas of origin since July 2012. Despite increased security, sporadic outbreaks of violence continue to result in small-scale displacement.
- Yemen hosts an increasing number of migrants and refugees—the majority from the Horn of Africa—who are also in need of humanitarian assistance. Yemen currently hosts nearly 240,000 refugees, a significant increase from the 150,000 refugees hosted in 2009.
- On September 29, 2012, U.S. Ambassador Gerald M. Feierstein reissued a disaster declaration for Yemen for
  FY 2013 due to continued humanitarian needs resulting from conflict and the impact of the country's political and
  economic crises on vulnerable populations.
