#### **Definition:**

Hospitalizations: Admission of an individual with suspected/probable/confirmed COVID-19 to a BHA-supported referral health facility for treatment. This includes patients received through referral pathways (from primary facilities or community referrals) and individuals admitted for inpatient care via the emergency department.

Referral facilities: Facilities which are designated as in-patient care for CoVID-19

Admission: Registration for a stay at an inpatient health facility for observation and/or specialized treatment, often overnight.

Numerator: N/A

**Denominator:** N/A

**Unit of Measure:** Number of individuals

**Disaggregated by:** Sex; Age (<5 years, ≥ 5 years)

**Suggested Data Collection Method:** Compile data from BHA-supported hospitals or health facilities providing inpatient COVID-19 care to calculate the sum total of hospitalizations.

**Suggested Data Source:** Hospital or Health Facility patient registers from BHA-supported facilities

#### INDICATOR DESCRIPTION

### **Definition:**

Risk communication and community engagement (RCCE) activities: outreach that includes key messages on COVID-19 prevention including: handwashing, respiratory hygiene, social distancing, when and where masks are appropriate, signs and symptoms of disease, and when to seek care.

Communication channel: the medium through which a message or information is transmitted to its intended audience.

Mass media (excluding social media) includes: TV, radio, newspapers, etc.

Non-mass media includes: training, community activities, etc.

Social media: Twitter, Facebook, etc.

**Unit of Measure:** Number of individuals

**Disaggregated by:** Mass media (TV, radio, newspaper, other); Non-mass media (training, community activities, mobile vans, other); Social Media (WhatsApp, Twitter, Facebook, Instagram, Snapchat, QQ, WeChat, etc.).

### **Suggested Data Collection Method:**

Mass Media: The number reached for a reporting period should be the estimated audience number for the media being used for the geographic areas being covered. If no audience estimates are available, the number reached can be estimated as the population with access to the media for the geographic area being covered. Double counting is inevitable if multiple media channels are used. To limit double counting, the parent (total) indicator should never exceed the total population living in the geographic areas where media messaging is being used. If estimates of reach <u>and</u> frequency are possible, please also report on an indicator documenting the number of impressions per person, or a similar metric.

Non-mass media: Records people trained, activities held and attendance, including for digital engagement.

Social media: Engagement should be tracked via standard metrics (page views, views, comments, etc.)

INDICATOR DESCRIPTION		
Definition:  COVID-19 screening or triage: A system for assessing all patients for possible COVID-19, to allow for early recognition and prioritization of care. This assessment is performed by trained staff, typically at the entrance to the facility, to identify patients with possible COVID-19 symptoms, medical history, or other criteria outlined in case definitions, to facilitate the early identification of cases of suspected COVID-19. (Note: testing is not included in these assessments).  Supported: Health facilities having received any type of training, rehabilitation, supplies and/or staffing with USAID/BHA funding.  Health facilities: All primary health care centers, mobile clinics, health posts, and any other health service delivery points supported with BHA funding.
