KEY DEVELOPMENTS

- On September 4, U.S. Deputy Secretary of State John J. Sullivan and USAID Administrator Mark Green announced more than \$120.2 million in additional USAID humanitarian funding for the Venezuela regional crisis response. The assistance, which includes approximately \$69.8 million from USAID/FFP and nearly \$50.5 million from USAID/OFDA, will enable non-governmental organization (NGO) and UN partners to continue providing critical multi-sector support to vulnerable populations in Brazil, Colombia, Ecuador, and Peru.
- As of early August, an estimated 4.3 million Venezuelans had left Venezuela due to the regional crisis, an increase of approximately 300,000 Venezuelans compared to early July, according to the Regional Interagency Coordination Platform for Refugees and Migrants from Venezuela, led by the International Organization for Migration (IOM) and the Office of the UN High Commissioner for Refugees (UNHCR). Of the overall total, approximately 3.5 million Venezuelans were in countries across Latin America and the Caribbean (LAC), including more than 1.4 million individuals in Colombia.
- The UN released the 2019 Venezuela Humanitarian Response Plan (HRP) on August 14, appealing for \$223 million to assist 2.6 million people across the country from July to December. The HRP increases awareness of humanitarian needs within Venezuela and underscores the importance of increasing international NGO presence and access in the country. In addition, the HRP highlights ongoing operational challenges that hinder relief efforts in Venezuela.

REGIONAL

- On August 26, health officials from the U.S., Argentina, Canada, Colombia, the Dominican Republic, Ecuador, Haiti, Panama, Paraguay, and Peru approved a measure to provide Venezuelans in the 10 countries with a regional vaccination card beginning in October, international media report. The agreement, reached during a meeting in Colombia's San José de Cúcuta municipality, Norte de Santander Department, aims to ensure that Venezuelans receive critical vaccinations and are not administered double doses of vaccines. In addition, health officials present at the meeting agreed to prioritize efforts to reduce disease transmission and treat malaria among Venezuelans in the region.

BRAZIL

- On July 24, the Government of Brazil (GoB) recognized more than 170 Venezuelans as refugees under the provisions of the Cartagena Declaration on Refugees—the first GoB use of the declaration to justify granting refugee status to individuals seeking the designation. The 1984 declaration expanded the refugee definition to include people who have fled countries of origin because of threats to life, liberty, or security due to disturbances to the public order, including foreign aggression, general violence, internal conflict, and significant human rights violations. The decision follows the June 14 formal recognition by the GoB National Refugee Committee of serious and widespread violations of human rights in Venezuela.
 - With nearly \$5.8 million in new USAID assistance, the Adventist Development and Relief Agency (ADRA) will reach more than 21,000 vulnerable Venezuelans and host community members in Brazil with food vouchers and hot meals, as well as messaging pertaining to nutrition-related best practices.
 - State/PRM partner Caritas provided blankets, clothing, diapers, food, and school supplies to more than 150 Venezuelans residing in a shelter in Brazil's Florianópolis city, Santa Catarina State, from August 3 to 9. Caritas also supported more than 30 Venezuelan households residing in the shelter with screenings for potential referral to public psychosocial support services.

CHILE

- On August 14, the Government of Chile announced revised requirements to enter the country under the terms of its special democratic responsibility visa. The new measures require Venezuelan adults to present an official criminal record and a valid passport, while Venezuelan children younger than 18 years of age must present a birth certificate and a valid passport. Venezuelans were previously only required to show proof of residency in any country in the region to apply for the visa, which allows Venezuelans to stay in Chile for one year and can be extended for an additional 12 months.

COLOMBIA

- On August 5, President of Colombia Iván Duque announced that the Government of Colombia (GoC) would grant citizenship to more than 24,000 children born to Venezuelans in Colombia since 2015, as well as to those born in Colombia by August 2021. The GoC previously required at least one parent to have legal residence in Colombia to confer citizenship on a child born in the country. The measure loosens that requirement, aims to accommodate the increasing number of Venezuelan arrivals in Colombia, and provides important protection measures for Venezuelans in the country. With State/PRM support, IOM, UNHCR, and the UN Children's Fund (UNICEF) plan to assist the GoC National Civil Registry in implementing the resolution, as well as in disseminating relevant information to Venezuelan parents.
- Venezuelans and Colombian returnees residing in nearly 450 informal settlements across Colombia's Arauca, La Guajira, Nariño, and Norte de Santander departments experience limited access to sufficient water, sanitation, and hygiene (WASH) services, resulting in increased risk of waterborne disease transmission, according to a July report

jointly produced by iMMAP and UNICEF. Approximately 44 percent of surveyed individuals reported no or inconsistent daily access to safe drinking water. In addition, overcrowding and lack of adequate shelter contribute to poor hygiene conditions in the settlements, with nearly 47 percent of respondents reporting three or more hygiene-related needs.

- With nearly \$84 million in additional assistance for Colombia, USAID continues to support partners to implement multi-sector relief programs across the country. Using \$20 million in new support from USAID, the UN World Food Program (WFP) will continue providing emergency food assistance, including food vouchers and hot meals, to vulnerable Venezuelans, Colombian returnees, and host community members in Colombia. Additionally, \$43 million in new support will allow two USAID NGO partners to implement multipurpose cash assistance (MPCA)—including cash transfers for food—and nutrition programming to reach vulnerable populations in the country.
- A USAID NGO partner reached nearly 3,000 people with health care services—including through clinical activities, health awareness sessions, mobile health units, and technical trainings—in Colombia’s Arauca, Atlántico, La Guajira, and Norte de Santander departments from August 5–15, bringing the total number of individuals reached since August 2018 to more than 73,800 people. With approximately \$5 million in new USAID support, the partner will continue to provide critical health care services for individuals in the four departments, as well as support health interventions for vulnerable populations in four additional departments.
- From July 31 to August 13, IOM provided more than 20,200 people with health assistance—including health consultations and referrals, technical training of health officials and community leaders, and vaccination activities—in Colombia. With \$4.7 million from USAID, IOM will continue to provide critical health services for vulnerable populations in the country. Since August 2018, the UN agency has reached approximately 97,000 people in Colombia with USAID support.
- State/PRM partner the Pan American Development Foundation (PADF) provided psychosocial support to 6,000 Venezuelan households and health and hygiene commodities to 3,000 Venezuelan households in Arauca from August 6 to 12. In addition, State/PRM partner Save the Children/U.S. (SC/US) facilitated recreational and psychosocial support activities for more than 70 children in two settlements in Arauca from August 5 to 10. SC/US also reached approximately 120 Venezuelans—including unaccompanied children and child survivors of gender-based violence (GBV)—with assistance, such as psychosocial support services, in La Guajira from July 29 to August 4.

ECUADOR

- The Government of Ecuador (GoE) announced on August 14 that Venezuelans seeking to enter the country would be required to request a humanitarian visa online through the GoE Ministry of Foreign Affairs; previously, the GoE only required Venezuelans to have a national identification card to enter Ecuador. From August 23 to 25, more than 11,000 Venezuelans entered Ecuador through the Rumichaca crossing, along the Colombia–Ecuador border, prior to the implementation of the new measure on August 26. In response, the Colombian Red Cross and GoC officials distributed food, safe drinking water, and winterization supplies, while UNHCR provided relief commodities, to populations at the border. As of August 28, the International Federation of Red Cross and Red Crescent Societies (IFRC) reported shelter gaps at Rumichaca due to the recent influx of individuals in the area.
- From July 16 to 19, USAID Disaster Assistance Response Team (DART) staff traveled to Ecuador’s Cuenca and Lago Agrio cities, as well as the country’s capital city of Quito, to meet with relief actors and observe USAID-supported food assistance programming in the country. Relief actors reported that priority needs among Venezuelans arriving in Ecuador include access to food, health care, legal and psychosocial support services, livelihood opportunities, and shelter. Relief actors reported the need for support in obtaining formal migration status in Ecuador and that many Venezuelans experience challenges related to discrimination and xenophobia when seeking employment or housing in the country.
- With USAID support, WFP provided food assistance to approximately 78,700 individuals across 10 Ecuadorian provinces in July. The assistance includes more than 58,600 people—nearly 89 percent of whom were Venezuelan—reached with food vouchers, approximately 16,300 vulnerable Venezuelans provided with one-time emergency food

assistance at migration checkpoints, and nearly 3,800 people given hot meals at community kitchens and shelters through WFP sub-partners. An additional \$13 million from USAID will enable WFP to continue reaching crisis-affected populations with emergency food assistance in Ecuador.

PERU

- As of June 15, Venezuelans are required to present a passport and visa—such as a business, humanitarian, migration, or tourist visa—to enter Peru, according to the Government of Peru (GoP). Most Venezuelans must obtain the humanitarian visa at GoP consulates in Venezuela prior to entering Peru; however, Venezuelans may obtain the visa from GoP consulates in Colombia and Ecuador in exceptional circumstances, the GoP reports. Venezuelans were previously permitted to enter Peru with either an identification document or passport.
 - With State/PRM support, PADF delivered legal and protection services to 200 vulnerable Venezuelans and advised more than 190 newly arrived individuals on issues such as migration status and service availability in Peru at points of entry in the country’s Tumbes Region from August 6 to 11. The NGO also facilitated a social inclusion activity for approximately 240 people in Peru’s capital city of Lima, as well as a workshop for 20 public officials from nine Peruvian regions to discuss the impact of migration and the potential benefits of migration for local populations.

TRINIDAD AND TOBAGO

- Following the end of the Government of Trinidad and Tobago’s (GoTT) May 31-to-June 14 registration period for Venezuelans residing in the country, the GoTT announced that as of June 17, Venezuelans require visas to enter the country, according to local media. Venezuelans are required to obtain the visas—which allow individuals to work and reside in Trinidad and Tobago for up to one year—at the Embassy of Trinidad and Tobago in Venezuela’s capital city of Caracas. Previously, Venezuelans were permitted to travel and stay in Trinidad and Tobago without a visa for up to 90 days.

VENEZUELA

- On August 14, the UN released the 2019 Venezuela HRP, requesting \$223 million to provide humanitarian assistance to approximately 2.6 million people across the country from July to December. The appeal includes funding for food security and livelihoods, health, nutrition, protection, and WASH programs, as well as education and humanitarian coordination activities, across Venezuela. The HRP highlights the need to increase the presence of international NGOs in Venezuela, advocates the formal recognition of international NGOs and staff in the country, and notes ongoing efforts to bolster humanitarian programming capacity among Venezuelan NGOs. In addition, the HRP underscores operational challenges related to the importation of relief supplies, insecurity, and limited access to border areas and remote locations in Venezuela. The HRP reflects input from the Venezuelan National Assembly and the administration of former President of Venezuela Nicolás Maduro and remains neutral in its references to political actors in Venezuela, protecting the integrity and impartiality of humanitarian assistance. U.S. Government (USG) staff are coordinating with international partners, including NGOs, UN agencies, and other donors, to determine ways to support HRP-aligned activities.

CONTEXT

- Deteriorating economic and political conditions—characterized by hyperinflation—in the Bolivarian Republic of Venezuela since 2014 have decreased households’ access to food, medicine, and health care; contributed to increasing humanitarian needs; and triggered an influx of Venezuelans into neighboring countries, including Brazil, Colombia, Ecuador, and Peru. More than 601,300 Venezuelans have applied for asylum globally since 2014.
- The population influx has increased in the past years and is straining available services, especially in border areas of Brazil, Colombia, Ecuador, and Peru. Recent assessments indicate that food, health care, and WASH support are among the most urgent humanitarian needs of vulnerable populations, including Venezuelans, returnees, and host communities in border regions. The outflow of people from Venezuela is also contributing to increased public health concerns throughout the region, particularly with regard to overburdened health care systems and the spread of infectious diseases.
- In addition to supporting ongoing regional response activities, USAID and State/PRM staff based throughout the region and in Washington, D.C., are monitoring the humanitarian situation in close coordination with relevant host governments, donor governments, NGOs, and UN counterparts.
