Summary of Responses by the U.S. Agency for International Development (USAID) to the Recommendations of the Board for International Food and Agricultural Development (BIFAD): Improving Nutrition Through Private-Sector Engagement Across Food Systems 178<sup>th</sup> BIFAD Public Meeting, October 16, 2018; Des Moines, Iowa

Recommendations 1-2: **Develop an investment strategy and learning agenda around private-sector engagement for nutrition**. USAID drafted an evidence report on private-sector engagement to improve nutrition outcomes through the food system. This evidence report serves as the foundation for the development of a private-sector strategy for nutrition, which is currently underway. We are holding internal Agency workshops to inform the strategy's development to operationalize our private-sector approach for nutrition. Furthermore, the strategy will include a robust learning agenda and appropriate indicators to measure success.

Recommendation 3: **De-risk investments for small and medium-sized enterprises** (SMEs). USAID is leveraging our partner project, the Investment Support Program, in collaboration with the Government of the Federal Republic of Germany, to analyze the market-landscape opportunities in Sub-Saharan Africa for SMEs to improve the quality of diets and address undernutrition. This work will inform our approach to addressing the business assistance needs of SMEs and creating potential finance mechanisms to de-risk market entry.

Recommendation 4: **Facilitate multi-stakeholder dialogues.** USAID has brought together private companies with donors and civil society to identify the barriers and challenges to improving the quality of data and food safety by using a food-systems approach. We plan to leverage our partnerships to convene additional, multi-stakeholder dialogues both at the global level, and within Feed the Future target countries, to identify opportunities where USAID can facilitate greater private-sector engagement for nutritious, safe foods.

Recommendation 5: **Increase consumer demand for more nutritious, safe foods.**USAID is working with its partners to develop tools to identify market factors that influence the food environment and, subsequently, consumer choice in different contexts. Once validated, Missions will have access to help them identify market-based approaches to improve the affordability and desirability of nutritious, safe foods. We are also assessing proven and promising social and behavior-change approaches that can scale up to increase consumer demand for nutritious, safe foods.
