## FY 2019, 3rd Quarter Business Forecast Questions and Responses

## Background

The Agency's Business Forecast is an informational resource on potential funding and partnership opportunities at USAID. It is an advanced look at grants, contracts, and cooperative agreements that FUSAID is in the process of developing and plans to issue in the coming year. Organizations interested in working with USAID can use this tool to plan for proposal or application submissions.

## **General Business Forecast Questions**

1. **Small Business:** USAID's Office of Small and Disadvantaged Business Utilization (OSDBU) indicated that USAID has plans to establish formal targets for small business utilization at the Mission level similar to the targets at USAID/Washington. Can USAID provide updates on the progress towards this goal and associated details (for example: will the targets be global aggregation, regional, country-specific, or some combination thereof)?

Can USAID clarify where small business goals per country can be found on the USAID website? When will targets and a full list of countries for FY20 be available? Will that list be published on the USAID website?

**USAID Response:** Currently, the following Missions are participating in USAID's Mission Small Business Goaling (MSBG) program: Ghana, Liberia, Malawi, Nigeria, Senegal, South Africa, Tanzania, Uganda, Zambia, Bangladesh, Indonesia, Nepal, Philippines, Vietnam, Bosnia and Herzegovina, Georgia, Kosovo, Ukraine, El Salvador, Guatemala, Honduras, Mexico, Peru, Egypt, Iraq, Jordan, Lebanon, Morocco, and Pakistan. The list of USAID Missions participating in the Mission Small Business Goaling (MSBG) is available via the Office of Small and Disadvantaged Business Utilization website: <u>https://www.usaid.gov/office-small-and-disadvantaged-businessutilization/documents/1878/mission-small-business-goaling-msbg-program</u>. The regional small business goals and previous fiscal year accomplishments will be posted on the agency's website within the next 30 days.

The OSDBU continues to provide Mission staff with small business training and guidance concerning various market research approaches (Sources Sought Notices, Industry Days, Request for Information, etc.) and acquisition strategies. In addition, the OSDBU is in the early stages of planning an overseas small business outreach activity to be held next calendar year.

2. **Small Business:** When USAID uses the term N/A under the Small Business Set Aside Column on the forecast, does that mean "not applicable" (meaning, this is confirmed not to be a small business set aside), or does it mean "not available" (meaning, this information is not yet available), or something else?

**USAID Response:** The term Not Applicable (N/A) under the Small Business Set Aside Column on the USAID Business Forecast often indicates that the contracting official cannot confirm if a requirement is suitable as a total or partial small business set aside at this stage of the acquisition planning process. Typically market research (Sources Sought Notice, Request for Information, etc.) has not been conducted prior to posting a requirement on the Business Forecast. Contracting officials may indicate "N/A" for new requirements or continuing projects

that were previously awarded to "other than small businesses". The contracting official should conduct market research prior to finalizing the acquisition strategy (i.e., small business set aside, full and open competition, etc.) and posting the requirement on the Federal Business Opportunities website. USAID recommends tracking requirements of interest to keep abreast of updates and cancellations.

3. **Business Forecast:** In multiple instances in last 6 months, USAID has listed procurements on the forecast as full and open and subsequently decided to release them under a different mechanism. As implementers, we take it seriously when opportunities are listed in the forecast and enlist significant financial and human resources behind preparing and designing projects that are free and open. What steps is USAID taking to ensure that the information in the forecast does not change in such a significant way? Will USAID provide an explanation for why the change was made and was not anticipated previously?

**USAID Response:** The Agency strives to have the Forecast be as accurate as possible. One of our goals for shifting to a real-time Forecast is to ensure that Partners are getting the most up to date information. As a part of the design process and through market research (such as RFIs, internal engagement) award types will shift. This is an inevitable part of the procurement process. We are committed to providing our partners with updated information as soon as possible.

If questions arise around why an activity shifts on the Forecast, we encourage partners to use our quarterly Forecast engagements to seek further clarification on why the change happened.

4. Business Forecast: In the last 2 weeks, several monitoring and evaluation RFPs have been released through GSA PSS that never appeared on the forecast and the release of the RFPs was not made public – only a limited number of companies were invited to bid. This is severely limiting to industry – there is no time to prepare, limited time to respond, and does not ensure the best solutions/proposals to the government. We hope USAID will recommit to posting all opportunities (no matter the mechanism) on the forecast so bidders can submit the most responsive and well-designed proposals to meet USAID's needs.

**USAID Response:** Thanks for bringing this to our attention. Please do not hesitate to contact the POC's for those opportunities and if needed, reach out to our Agency Ombudsman. We will remind CO's to mindful of the time turn around and to post GSA opportunities.

5. **Category Management:** Can USAID clarify which agency-wide IDIQs count towards the Agency's category management goals?

**USAID Response:** All IDIQs count towards the Agency's CM goals. The BIC goal however is more challenging to meet since only a handful of IDIQ vehicles count toward the BIC goal. USAID has made awards under the following BIC vehicles and you can expect to see more awards under these and other BIC vehicles in the future.

The BIC solutions USAID has awarded in both FY 2018 and FY2019 include:

- 6. **Missing Missions and Offices:** There are 46 missions represented on the forecast out of 117 countries receiving funding. There are 51 Washington DC offices and 23 are represented What should implementers assume regarding missing countries and offices on the forecast? Can USAID include "no requirements" when there are none?

**USAID Response:** Our systems and process only support reporting opportunities that are available. Yes, implementers should assume no requirements (or no opportunities) are available (as of yet) for those offices that are not posted. We do check the forecast and reach out to Offices and Missions that should have opportunities posted and provide numerous reminders and communications for them to confirm they have posted all opportunities.

7. **Business Forecast Information:** Information in the description box often lacks sufficient details for implementers to make a decision to bid, can M/OAA please periodically review this section and counsel Missions if needed? In addition, In the incumbent column there are entries that include a name, TBD, N/A or left blank. Can USAID emphasize the importance of this field?

**USAID Response:** USAID will continue to emphasize the importance of providing as much information as possible in the Business Forecast, including information such as the incumbent and activity description. We will conduct periodic reviews of the Forecast to ensure that this information is available.

8. **Choice of Instrument:** Can USAID emphasize choice of instrument and set-aside earlier in the process to give more time to team etc.?

**USAID Response:** USAID will continue to emphasize the importance of providing this information on the Forecast as soon as possible.

9. Category Management Goals: In previous Business Forecast Q&A calls, USAID OAA has indicated that it intends to begin directing development programming through OASIS and that implementing partners should "do all they can to get on OASIS". However, in the case of non-small businesses (OASIS UNR), many traditional USAID implementing partners would not qualify for OASIS during the on-ramp given the size and scope of their respective contract portfolios. At the same time, other USAID representatives have indicated that, on the contrary, USAID intends to achieve its 20% BIC goal through a combination of other GSA mechanisms such as PSS and rely on OASIS primarily for materials and service contracts such as IT, travel management, janitorial, office supply/services, etc. Could you please clarify USAID's goals and expectations with regard to the use of OASIS for development programming specifically?

**USAID Response:** USAID intends to meet our CM, socio economic and our J2SR goals. However, we have consistently messaged that we will not disrupt our J2SR goal to meet the CM goals. In other words, if a development programming effort had just two options, either a non-IDIQ solution to meet the J2SR goal or an IDIQ solution that would <u>not</u> meet the J2SR goal, <u>J2SR will</u> <u>prevail</u>. To meet our CM goals without disrupting our J2SR goals, we are encouraging our acquisition staff to consider other areas such as IT, travel, monitoring and evaluation contracts, office supplies, etc. OASIS, both large and small, offers opportunities for the Agency to meet our BIC goal and we intend to promote the use of all BIC vehicles to the full extent possible – again without disrupting development programming toward our J2SR goal.

10. New Activities on the Forecast: When activities are entered on the USAID Business Forecast, the new listing is included in the Business Forecast Status Change column with a "New Opportunity Not Previously Forecasted" designation. Upon occasion, that designation does not change over time even though other items in the status of the activity may be changed. Would USAID consider including the date the new opportunity is added to the forecast to minimize confusion as additional changes are made?

**USAID Response:** Thanks for bringing this issue to our attention. We will look into our system capabilities.

11. **Collaborative Agreement:** USAID has recently used the term "collaborative agreement" to designate an award mechanism. Could USAID please provide reference information on the collaborative agreement mechanism and describe how USAID intends to use this mechanism in the future?

## **USAID Response:**

Collaborative agreement is a term being utilized for a procurement approach that emphasis the use of Co-creation with our implementing partners as a means of developing new program descriptions. This method can be utilized for any Acquisitions or Assistance mechanism. More information can be found in the links below:

12. **New Partnerships Initiative:** Have any awards been made under the Annual Program Statement (APS) for New Partnership(s) Initiative?

**USAID Response:** No, none have been made yet under the NPI DCHA APS but USAID is currently in final negotiations with several organizations in Erbil, Iraq. The awards that will result from these negotiations will be direct grants to first-time Iraqi recipients that are being achieved through the co-creation process. The NPI GH APS has not been released yet. Please see the response to Question #37 below.

13. Northern Triangle Programs: Can USAID please advise if future funding opportunities in El Salvador, Guatemala, and Honduras will be cancelled?

**USAID Response:** Authorization to award new projects are on hold for NT countries until guidance is provided from DOS on future availability of funding (FY19 and beyond). Please contact the cognizant CO/AO for additional information on a specific solicitation.

14. **Co-Creation in the Forecast:** To allow organizations to prepare better for upcoming solicitations, and given the increasing number of solicitations that are using a co-creation process, would USAID consider indicating in the forecast whether a co-creation process is envisioned for listed opportunities?

**USAID Response:** We will consider if/how this information could be incorporated more formally into our Business Forecast. At a minimum, we will encourage our staff to include in the Award Description if they intend to use co-creation be it a specific co-creation engagement or other collaborative techniques such as the release of an RFI, Statement of Objectives, Industry Days, etc. as a part of the A&A process.

15. **Guidance on PWS and QASP:** An increasing number of USAID RFPs are requesting Performance Work Statements (PWS) and Quality Assurance and Surveillance Plans (QASP). The RFPs and COs responses to questions have provided limited guidance regarding the content and format desired. Can the Office of Acquisition and Assistance provide guidance on or direct partners to resources on what USAID expects in a PWS and QASP?

**USAID Response:** Guidance and expectations for PWS and QASP can be found in FAR 37.602 and FAR 46, respectively.

16. **Washington:** USAID has multiple opportunities on the forecast listed as GSA Task Order / Delivery Orders. Does USAID maintain an interested parties list for distributions?

**USAID Response:** USAID follows FAR part 8 and GSA guidelines for contacting contractors that currently hold the GSA contract.

## **Washington Business Forecast Questions**

1. **AFR:** Does USAID anticipate any upcoming amendments to Broad Agency Announcement for Sustainable Development in Sub-Saharan Africa, BAA-AFR-SD-2019?

USAID Response: No Addenda are expected this fiscal year.

- 2. BFS: Policy Analysis and Capacity (PAC)
  - a. Can USAID please forecast if any additional opportunities will be coming out under this opportunity; mechanism number: 7200AA19APS00003?

**USAID Response:** We do anticipate additional opportunities under the PAC APS, which could include central funding (Washington) or mission funding. The timing and funding availability of these potential opportunities, however, is unknown at this time.

- 3. BFS: Market Systems and Partnership
  - a. Can USAID please clarify whether the Market Systems and Partnerships opportunity will be full and open or a U.S. small business set-aside?
  - b. Could USAID please provide an update on the anticipated release date/award date of Market Systems and Partnerships Activity?
  - c. Could USAID please provide an update on the anticipated award type for this activity?

**USAID Response:** MSP will be a full and open competition, however there will be a small business subcontracting requirement. We hope to issue the solicitation before August 2019. We anticipate a cost reimbursement type contract for this activity.

- 4. DCHA: Support Which Implements Fast Transtion (SWIFT) IDIQ
  - a. Can USAID provide the anticipated award date?

**USAID Response:** USAID is unable to predict an exact award date. We are estimating an award date Q4 of FY 2019.

# 5. DCHA: FEWS Net

- a. Does USAID have a target by which Task Order 1 will be awarded?
- b. Would USAID please provide details on the anticipated timing and scope of any future task orders under the FEWS NET 7 IDIQ?

**USAID Response:** USAID recently awarded a task order for FEWS NET "Learning and Data Hub" services and is currently working towards awarding a task order for Pillar 1 services. At this time USAID has no information to provide. IDIQ holders will be contacted directly regarding future task orders under the FEWS NET 7 IDIQ.

- 6. DCHA: Global Reconciliation Fund
  - **a**. We recognize that the Global Reconciliation Fund is typically procured on an annual basis. Does USAID anticipate issuing this procurement this year, and if so, is there a timeline that USAID can share?

**USAID Response:** USAID anticipates releasing an Annual Program Statement (APS) on People to-People Reconciliation (P2P) in August, 2019. Currently eligible countries include the following:

Bangladesh, Bosnia and Herzegovina, Central African Republic, Dominican Republic/Haiti Cross-Border, Georgia, Guinea, Jamaica, Kosovo, Liberia, Mozambique, Paraguay, Philippines, Republic of the Congo, South Sudan, Sudan, Timor-Leste, Zimbabwe

As additional eligible countries are confirmed, those Missions will post a country-specific Addendum to the APS. Please note that the first Addendum to the APS will be released concurrently to the APS and will likely include country-specific information from 8-10 of currently participating country Missions. Each Addendum will be posted for a minimum of 60 days on www. <u>grants.gov</u>, during which time Applicants can develop a Concept Note for submission to the identified country point of contact.

# 7. DCHA: Promoting Internet Freedom

a. When does USAID anticipate releasing the Promoting Internet Freedom solicitation and through which funding mechanism?

USAID Response: No additional information is available at this time.

# 8. DCHA: Rule of Law IDIQ

a. Does USAID anticipate releasing another Rule of Law IDIQ? If so, what is the anticipated release date?

**USAID Response:** The ACES IDIQ and ACES APS will serve as the follow-on mechanisms to the Rule of Law IQC.

- 9. DCHA: Active Communities-Effective States IDIQ (USAID ACES)
  - a. Could USAID provide an update on the anticipated award date of the Active Communities Effective States (ACES) IDIQs?

**USAID Response:** USAID is unable to predict an exact award date for the ACES IDIQs.

- 10. DCHA: Active Communities-Effective States APS
  - a. Can USAID share any information about the timeline for the ACES APS?
  - b. Can you provide any information on plans for the USAID ACES APS?
  - c. Is USAID aware of any addendum that are planned for this mechanism?

**USAID Response:** The ACES APS is finalized and published. The ACES APS was published on <u>www.grants.gov</u> on April 11, 2019 with a closing date of April 10, 2020. Addenda to the ACES APS will be posted on <u>www.grants.gov</u> and each addendum will indicate a timeline for submission of Concept Notes. At the present time, no more than cursory inquiries from Missions have been made regarding the use of the ACES APS.

- 11. E3: Energy II IDIQ
  - a. Does USAID have an update on the status of the Energy II IDIQ award process?
  - b. Is there an expected award date for the Energy II IDIQ?

**USAID Response:** USAID plans to have the Energy II IDIQ awarded in August 2019.

12. E3: Does USAID intend to procure a contract for blended finance learning this fiscal year?

**USAID Response:** Yes, USAID does.

13. **E3:** Does USAID anticipate releasing follow-ons for Advancing Basic Education: Access for All (ABE-ACCESS) or Advancing Basic Education: All Children Reading (ABE-ACR) IDIQs?

USAID Response: No, USAID does not.

14. **E3:** Can USAID provide an update on whether or not a global education program will be released within the next 2 quarters?

**USAID Response:** E3 Bureau is not contemplating a solicitation for a global education IDIQ or LWA (or similar type of mechanism) within the next two quarters.

## 15. E3: REPLACE IDIQ

a. Will there be a follow on to this IDIQ?

**USAID Response:** No information is available at this time.

- 16. E3: Making Cities Work
  - a. What is the anticipated release date of the MCW II IDIQ?

USAID Response: No information is available at this time.

## 17. E3: Clean Cities, Blue Ocean Task Order

a. I see that the "Clean Cities, Blue Ocean" task order will be issued under the Making Cities Work (MCW) IDIQ. Has the MCW IDIQ been extended? If so, what is the current end date for the IDIQ?

**USAID Response:** The ordering period for the IDIQ has not been extended. However, the limit for the period of performance for task orders has been extended from two years to five years after the end of the ordering period.

## 18. E3: PSE Learning under BOA

- a. Could USAID please define "BOA" in the task order title "PSE Learning under BOA" on the forecast?
- b. Could you please identify which IDIQ this opportunity will be released under?
- c. Can USAID provide more information about the scope of this anticipated project?

**USAID Response:** A "BOA" stands for Basic Ordering Agreement. The solicitation was released to holders of the INVEST+ Basic Ordering Agreement, not under an IDIQ. The RFP included a Statement of Objectives related to monitoring, evaluation, learning of USAID's efforts to mobilize private capital.

- a. Can USAID please confirm if the Advancing the Evidence Base and Community Building is a new requirement or is there an incumbent contractor?
- b. Given the value of this award, will it also be set aside for small business?

**USAID Response:** a) New Requirement and b) The solicitation was a RFQ issued to under GSA's PSS (MOBIS) Federal Supply Schedule contract in accordance with FAR 8.405 on June 20 - it was not set-aside for small business.

- 20. E3: Training, Research, Analytics, and Communications Support
  - a. Could USAID please provide an updated release date for this opportunity, since the anticipated solicitation release date has passed?
  - b. Under what mechanism does USAID intend to procure the Training, Research, Analytics and Communications Support contract?

**USAID Response:** M/OAA/E3 released this RFQ on Monday, July 1st. The solicitation was a RFQ issued to small businesses under GSA's PSS (MOBIS) Federal Supply Schedule contract.

- 21. E3: WADI IQID
  - a. Does USAID anticipate a second WADI IDIQ? If so, what is the anticipated release date?
  - b. To date, there has not been any information on the USAID Business Forecast about a Water and Development IDIQ (WADI) follow-on activity. Is there any information you can share, such as when a pre-solicitation or RFI might be expected?

# USAID Response: No information is available at this time.

- 22. E3: Youth Power
  - a. Does USAID intend to release a YouthPower 2 implementation mechanism to complement the Youth Power 2 Learning and Evaluation opportunity?
  - b. Can you please provide an update on the global Youth Power 2.0 IDIQ procurement release date
  - c. The YouthPower 2 Learning award is currently listed as a GSA DO. Would USAID please provide information about why it may use a GSA schedule for this opportunity?
  - d. Could USAID provide insight on whether there will be a companion implementation mechanism under YouthPower 2 in addition to the Learning mechanism?
  - e. Would USAID be able to offer an update on the expected timeline for releasing the YouthPower solicitation(s)?
  - f. Does USAID expect to have any set-aside awards under the YouthPower umbrella?

**USAID Response:** RFQ#7200AAQ00024 - YP2LE is a requirement to procure the YouthPower 2 Learning & Evaluation (YP2LE) services. At this time, no additional information is available.

## 23. Food for Peace: <u>Development Food Security Activities (DFSA)</u>

- a. Can USAID provide any information on DFSA priority countries in FY 2020?
- b. Does USAID anticipate releasing a DFSA opportunity in Zimbabwe in FY20?

**USAID Response:** At this time, USAID can not discuss any DFSA design or procurement activities due to standard procurement sensitivities. Any forthcoming DFSA procurement

document will be sent out as a draft for comment to the Food Aid Consultative Group and Posted on grants.gov and the USAID website.

- 24. Global Development Lab: Science and Technology Policy Fellowship Program 2019
  - a. There was Sources Sought Notice (SSN) issued in January on Fellowship, Reference number: NOOAA19ROOOII. Do you plan to release RFQ on it? If yes, when?
  - b. Can USAID please confirm if it intends to release the Science & Technology Policy Fellowship (STPF) program in 2019 and what the potential time frame might be?

**USAID Response:** The Sources Sought Notice was posted and released for the purposes of Market research only without a commitment of an RFP. it is however anticipated that USAID will start the review of a possible solicitation in FY2020 based on the results of the Market Research provided by potential offerors.

25. **Global Health:** Does USAID/Washington anticipate releasing any future Global Health Security Agenda procurements?

**USAID Response:** Global Health Security (GHS) are generally emergency supplemental funds so there are no new GHS awards planned at this time. GHS funds can be used in existing awards where responding to emergency situations fall under the scope of the award. GHS activities will likely fall under the One Health Workforce Next Gen (OHW-NG) and the Innovations for Addressing Emerging Zoonoses and Antimicrobial Resistance BAA awards being competed under the Emerging Threats Division (ETD). Both those solicitations have closed.

26. **Global Health:** Could USAID please provide an update if there is a newer USAID Global Health User's Guide since the last one published online in January 2018?

**USAID Response:** The published versions of the USAID Global Health User's Guide in PDF has been converted into an interactive feature to conduct searches of the mechanisms at this new website address: <u>https://gh-usersguide.usaid.gov/</u>.

27. **Global Health:** Would USAID please clarify if there is a follow-on plan to support activities currently supported by the Human Resources for Health (HRH) 2030 program?

**USAID Response:** Any follow-on plans to support activities under HRH2030 will be announced in the business forecast.

28. **Global Health:** Would USAID please clarify if there is a follow-on plan to support activities currently supported by the Health Policy Plus (HP+) project?

**USAID Response:** The Health Policy Plus (HP+) project currently ends in August 2020; any follow-on procurement will be advertised on the Business Forecast.

# 29. Global Health: MEASURE Evaluation

- a. Does USAID plan to release a follow-on to MEASURE Evaluation Phase IV?
- b. If so, when does USAID expect to post the solicitation?
- c. Can USAID provide any other relevant Forecast details?

**USAID Response:** USAID does not plan to release a follow-on to MEASURE Evaluation Phase IV. The health information systems work performed under MEASURE Evaluation Phase IV will now be implemented under The Translating Data for Implementation (DFI) under the President's Emergency Plan for AIDS Relief (PEPFAR) Cooperative Agreement which was awarded April 15, 2019.

- 30. Global Health: Sustaining Health Outcomes through the Private Sector (SHOPS) Plus
  - a. Does USAID/Washington intend to issue a follow-on to Sustaining Health Outcomes through the Private Sector (SHOPS) Plus? If so, does USAID anticipate issuing an RFI before the full solicitation, and could USAID provide any information such as anticipated timing of the solicitation, project scope, award mechanism, or award date?

**USAID Response:** We are currently in the design stage of a private sector health systems procurement, with an anticipated Q4 2020 award date. Please continue to monitor the business forecast for future updates.

- 31. Global Health: Support for International Family Planning Organizations 2 (SIFPO2)
  - a. Does USAID/Washington still intend to issue a new private sector award following the end of Support for International Family Planning Organizations 2 (SIFPO2)?
  - b. If so, does USAID anticipate issuing an RFI before the full solicitation, and could USAID provide any information such as anticipated timing of the solicitation, project scope, award mechanism, or award date?

**USAID Response:** SIFPO 2 will not be recompeted. A set of similar activities are currently being procured through the MOMENTUM Annual Program Statement, through Round 2B.

# 32. Global Health: Momentum APS

- a. Can you provide background and what exactly is the "momentum" program?
- b. Does this APS primarily call for partnerships to implement the momentum program?
- c. What are the terms of the partnership?
- d. Can USAID provide further information on the technical scope for MOMENTUM Round 3 and what USAID means by "entrenched obstacles"? Could USAID please provide some examples for topics that it considers to be "entrenched obstacles" that are to be addressed through this round?
- e. For Round 3, how many awards does USAID anticipate making?
- f. Does USAID anticipate additional rounds being released in the next two quarters? If so, does what topics does USAID envision these future rounds will cover?
- g. Does USAID expect to issue an APS for fistula care under Momentum? If yes, when? If not will there be a global fistula NOFO?

**USAID Response:** MOMENTUM stands for "Moving Integrated, Quality Maternal, Newborn, and Child Health and Family Planning and Reproductive Health Services to Scale." The purpose is to accelerate reductions in maternal, newborn, and child mortality and morbidity in high-burden, USAID-supported countries by increasing the capacity of host country institutions and local organizations to introduce, deliver, scale up, and sustain the use of evidence-based, quality maternal, newborn, and child health (MNCH), voluntary family planning (FP) and reproductive health (RH) services. The APS does not specifically call for defined partnerships; however, a Round may add additional requirements for eligibility. Overall, MOMENTUM will include a greater focus on building the capacity, sustainability, and resilience of local partner institutions, while maintaining an emphasis on advancing the scale-up of evidence-based approaches and interventions. MOMENTUM awards will seek to issue performance-based, capacity-building, and/or innovation sub-awards and sub-grants to local organizations which may, in time, become transition awards [Under MOMENTUM, a transition award is defined as a partner which previously received funding as a sub-awardee and has now transitioned to receiving direct funding from USAID or other donors.]

Entrenched Obstacles Rounds will seek to identify and apply innovative approaches to overcome identified obstacles to reducing maternal and child morbidity and mortality and reducing unmet FP need. - c. Will USAID release a Request for Information, Scope of Work, or utilize another cocreation mechanism to inform the design of the USAID/DRC Forestry and Biodiversity Support Activity?
- d. Is USAID redesigning the USAID/DRC Forestry and Biodiversity Support Activity in light of the current TIP sanctions imposed on the Democratic Republic of Congo?

**USAID Response:** The anticipated release date is August 30, 2019. The target zone is the Central African Sub-region. There will be no request for information nor use of co-creation. This will be a full and open procurement for the award of a hybrid contract (CPFF/IDIQ). Regarding the impact of TVPA sanctions, USAID is currently considering a variety of options and will clarify them in the solicitation. At the moment, there is no plan to redesign the activity.

- 35. Democratic Republic of the Congo: Conservation Through Economic Empowerment
  - a. Could USAID please provide an update on the anticipated release date/award date of the USAID Conservation Through Economic Empowerment in ROC opportunity?
  - b. Will the USAID Conservation Through Economic Empowerment in ROC opportunity be a small business set-aside?

**USAID Response:** The anticipated release date is the end of August. No, this will not be a small business set-aside.

## 36. Democratic Republic of the Congo: Strengthening Livelihoods and Resilience

a. Would USAID kindly provide any update regarding the anticipated solicitation release date?

**USAID Response:** This solicitation is anticipated to be released in early August 2019.

## 37. Democratic Republic of the Congo: Gender Empowerment

a. This opportunity has been removed from the forecast but was previously listed as a contract anticipated for release in May 2020. Would USAID confirm whether this opportunity is still planned and provide detail regarding the anticipated timeline and planned procurement mechanism?

**USAID Response:** This activity is no longer planned. USAID/DRC made a determination that gender empowerment should be mainstreamed in the other basic education activities.

- 38. Democratic Republic of the Congo: <u>DRC Prevention of Mosquito-Borne Diseases through</u> <u>Vector Control</u>
  - a. Can USAID provide more information related to the DRC Prevention of Mosquito-borne Diseases through Vector Control opportunity status? What mechanism will it come out of?

USAID Response: Additional information is not available at this time.

**USAID Response:** USAID is planning two follow-on activities in the education sector. One will an assistance focusing on flexible and responsive education services for conflict affected children and youth, with mid-to-late September 2019 as the anticipated solicitation release date. The other will be an acquisition instrument to implement an early grade reading activity. The anticipated solicitation release date for the latter is early November 2019.

# 40. Democratic Republic of the Congo: Basic Education Activity

- a. Basic Education Activity is listed as a contract but has a number of components that typically fall under a cooperative agreement, like gender gaps and reduction of barriers that could be informal or cultural, will there be room under this contract for subs awardees to be grantees? **USAID Response:** Yes. There will be a GUC component to this activity. USAID/DRC made a determination that gender empowerment should be mainstreamed in the other basic education activities, so there is no longer a stand alone procurement for this activity.

**USAID Response:** It is our assumption that yes, activities considered "assistance to the government of the DRC" will continue to be prohibited. Over the past couple of weeks though, several activities were cleared and are being implemented as initially planned. We assume that it will be the case going forward, and activities will be cleared by Washington on a case by case basis. For activities not cleared, the Mission has put in place a process called "de-scoping" where "assistance to government" activities are removed from the main award, provided that doing so does not undermine our ability to achieve the objective(s) sought through those projects. Delays in the release of funding to USAID/DRC do not have a serious impact on any of our solicitations.

43. **Democratic Republic of the Congo:** Does USAID anticipate releasing any solicitations related to governance/peacebuilding within the next 24 months? If so, could USAID confirm the anticipated timing and whether a RFI will be published beforehand

**USAID Response:** The Democracy, Rights and Governance (DRG) and the Peace and Security Office (PSO) are currently discussing the idea of a joint activity. Nothing concrete has come out of these discussions yet.

# 44. East Timor: Avansa Agrikultura

- a. Does USAID anticipate a follow-on to Avansa Agrikultura?
- b. If yes, what is the expected release date?
- **C.** If yes, does USAID intend to release a draft scope of work or a Request for Information for this program?

**USAID Response:** Yes, USAID anticipates a follow-on to Avansa Agrikultura. The expected release date is still to be determined. Yes, USAID intends to release a Request for Information for this program. The mechanism has not been determined at this moment.

- a. Has a determination been made as to whether this will be a small business set-aside?
- b. Will this procurement be full and open competition, or, will this be released under an existing IDIQ? If this will be released under an existing IDIQ, can USAID share the name of the intended IDIQ?
- c. Could USAID confirm the Award/Action type?

**USAID Response:** The design of the Expanding Government Reform is still ongoing. The decision on the mechanism or small business set-aside has not been made.

## 46. East Timor: Strengthening Organizational Capacity of CSOs

- a. Can USAID please confirm that the East Timor Strengthening Organizational Capacity of CSOs will be awarded as a contract, per the previous forecast Q&A?
- b. In the FY19 Q3 Business Forecast Q&A, USAID noted that the East Timor "Strengthening Organizational Capacity of Local CSOs" project would be released as a contract. Could you please provide justification as to how the decision for a contract, rather than cooperative agreement, mechanism was determined?
- c. Can USAID clarify the intended award amount?
- d. Does USAID anticipate releasing a pre-solicitation or request for information for this opportunity?
- e. Can USAID provide any additional information on the scope of work?
- f. Does USAID anticipate a full and open competition for this award?

**USAID Response:** The East Timor Strengthening Organizational Capacity of CSOs will be awarded as a contract. USAID determined that acquisition is the appropriate instrument for the activity based on the criteria specified in Section 6303 the FGCAA (31 USC § 6303 – Using Procurement Contracts). This contract instrument has the principal purpose of acquiring supplies and services for the performance of achieving the objectives of this activity.

The Mission intends to use Statement of Objectives in order to provide flexibility to offerors to propose innovatives approaches to achieving USAID's objectives. The intended award amount is estimated to be between \$4M and \$9.99M.

A Request for Information for this activity was released in March 2019. The Mission is completing documentation to move toward solicitation. No additional information is available at this time, but USAID is considering posting a draft solicitation prior to solicitation. USAID anticipates a full an open competition for this award.

# 47. Egypt: Building Egypt's Skilled Workforce

a. Is USAID planning to issue a pre-solicitation notice and more information about the SOW before the projected release date of June 15, 2020?

**USAID Response:** USAID/Egypt is considering issuing a pre-solicitation notice. It is not yet decided.

b. Can USAID confirm that firm-level business development services will be part of "Business Egypt" and will not be part of "Building Egypt's Skilled Workforce"?

**USAID Response:** USAID Response: USAID/Egypt is considering issuing a pre-solicitation notice. It is not yet decided. With regards to the BDS, this is still not determined.

## 49. Egypt: Women's Empowerment

- a. Could USAID please confirm the anticipated release date of the opportunity given the release of the RFI as well as the mechanism the solicitation will be released under?
- b. Could USAID provide clarity on the intended procurement mechanism?
- C. With the release of an RFI earlier this month, could USAID confirm if the timing of 7/31 is still accurate?
- d. The RFI shared depicted a project focused on women's economic empowerment, the forecast project description remains focused on GBV response, which does USAID intend to focus on?

**USAID Response:** USAID/Egypt is still reviewing responses to the RFI issued on June 10 and closed on July 2. We are considering a co-creation process that may result in a contract and/or grant mechanism. Once a determination is made on the procurement process, the business forecast will be updated with a new release date. We will update the Business Forecast description to have it more consistent with the latest thoughts on this activity reflected in the RFI.

- 64. Ghana: SHOPS Associate Award
  - a. Can USAID please confirm whether there will be a follow-on to the work implemented under the SHOPS Associate Award in Ghana?
  - b. If there will be a follow-on to the work implemented under the SHOPS Associate Award in Ghana, can USAID please confirm the mechanism, release date, and whether the procurement will be limited to Ghanaian firms as primes?

**USAID Response:** SHOPS Associate award is currently scheduled to end September 2020. USAID/Ghana does not anticipate any follow on.

Can USAID please confirm if it intends to release a Feed the Future solicitation in FY19? If so, what is the anticipated release date and mechanism (Contract or Cooperative Agreement)? **USAID Response:** We are designing new activities under the GFSS. We suggest to continue to monitor the Business Forecast for more information about them.

**USAID Response:** At this time we cannot confirm any open solicitations for either Sri Lanka or Maldives as future planning is currently ongoing. **USAID Response:** Yes, USAID intends to issue a follow on to the Tanzania Community Health System Strengthening activity. In addition, we intend to issue an RFI. The award will be a contract. The Total Estimated Cost/Amount Range is \$24,999,000-\$50,000,000. The anticipated solicitation date is April 30,2020. Geographic scope is not available at this time.

- 225. Tanzania: Tanzania Public Sector Systems Strengthening Next Generation project
  - a. Can USAID provide any more information on the Tanzania Public Sector Systems Strengthening Next Generation project?

**USAID Response:** PS3 Next Generation project will provide technical assistance to the Government of Tanzania to institutionalize public systems that are responsive to citizens' needs for quality services at the local level, particularly for underserved populations. The project will support the Government of Tanzania to improve evidence-based, inclusive planning and management at local levels; strengthen local governance to promote citizen engagement and social accountability; and increase efficient use of financial resources.

A Stakeholders' consultative meeting was held on February 26, 2019, and the notes from the meeting was shared on Fedbizopps on April 02, 2019. USAID/Tanzania expects to post the draft Performance Work Statement (PWS) on Fedbizopps for comments before the end of July 2019.

**USAID Response**: Yes, USAID intends to issue a follow on to the Tanzania Support of Orphans and Vulnerable Children, adolescents and Young people, as well as an RFI. The action type, geographic scope, as well as the amount is still to be determined. The anticipated release date is July 30,2020.

**USAID Response:** USAID does not expect the scope of the activity it to be different. There is currently no plan to issue another RFI. The activity is still expected to be released on 8/28. Additional information is unavailable at the activity is still under design.

The successful offeror will be expected to support all districts within the target provinces.

**USAID Response:** The release date has been updated to 9/16/2019. USAID is anticipating releasing an RFI. There is no additional information to provide beyond what is currently on the business forecast. It will be a contract, please refer to information on the business forecast. This project will be located in the Eastern Province and Peri-Urban Lusaka. This activity will not include malaria activities.

253. **Zambia:** Could USAID/Zambia provide any additional information regarding the anticipated social protection, OVC, or DREAMS-focused solicitations mentioned in previous Q&A rounds?

**USAID Response:**The Social Protection Program will comprise of three activities, namely the OVC service delivery; OVC technical assistance and a government to government program (G2G). **USAID Response:** The ZAM Health activity will be a cooperative agreement. The business forecast has been updated accordingly. USAID intends to restrict to local primes. The ZAM-Health activity does not limit work with private providers to social franchisees. USAID is open to non-franchised provider networks.

## 257. Zambia: <u>HIV Prevention for Key and Target Populations</u>

At this point, we are planning for this to be PEPFAR funded. However, it may be possible that other USAID Health funds may be included at a later date. There could be up to two awards

Yes, gender-based violence (GBV) prevention will be part of the project as GBV is a component of the USAID and PEPFAR prevention strategy.

**USAID Response:** Yes, this activity will be added back to the Forecast. The anticipated solicitation date is 9/2019. The activity will be limited to local organizations. It will not include a DREAMS focus.

- 259. Zambia: Program for the Advancement of Malaria Outcomes (PAMO) Follow-on
  - a. Will there be a follow-on to PAMO in Zambia? If so, can USAID share any information on the anticipated timeline for this solicitation?

**USAID Response:** To be determined. Please continue to monitor the business forecast for information.

- 260. Zimbabwe: <u>Strengthening of the Human Resources Information System</u>
  - a. Could USAID please confirm whether a competitive follow-on to the Strengthening of the Human Resources Information System (PEPFAR) program is expected?
  - b. If yes, could USAID confirm the anticipated timing and whether a RFI will be published beforehand?

**USAID Response:** Following market research for local organizations, USAID determined that it will pursue a non-competitive award.

261. **Zimbabwe:** Can USAID provide more information related to the Assistance Program in Malaria follow-on?

**USAID Response:** USAID is in the planning process and anticipates issuing a Notice of Funding Opportunity in the first quarter of Fiscal Year 2020.

262. **Zimbabwe:** Can USAID please confirm if it intends to release any additional procurements (aside from the Accountability and Rights opportunity already on the Mission Forecast)? If so, when can any new opportunities be expected?

**USAID Response:** USAID is in the process of developing priorities for FY 2020. We anticipate issuing new opportunities in the first or second quarter of FY 2020.
